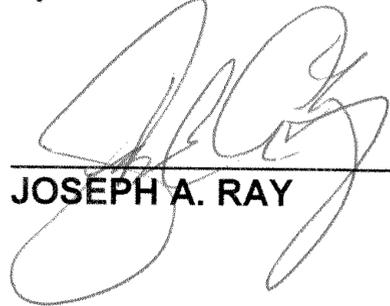
Lot 2, according to the Survey of McPherson Estates, as recorded in Map Book 41, Page 9, in the Probate Office of Shelby County, Alabama.
