

**ARTICLES OF ORGANIZATION
OF

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, Wayne Lowe, acting as member of a limited liability company under the laws of the State of Alabama, hereby adopts the following Articles of Organization for AU COLLEGE LIFE, LLC (hereinafter referred to as "Company"):

ARTICLE 1

NAME OF COMPANY

The name of the Company shall be AU College Life, LLC

ARTICLE II

PERIOD OF DURATION

The period of duration for the Company shall be fifty (50) years unless terminated or extended by written Agreement of the members.

ARTICLE III

OBJECTS AND PURPOSES

The objects and purposes for which the Company is organized are:

1. To plan, organize and conduct reunion meetings for various affinity groups; to provide consulting and management services regarding same; to buy, sell, market, repair, build, construct, or refurbish all types of properties; to lease rent or manage all types of residential or commercial properties.
2. To transact any and all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act, as such act may from time to time be amended.
3. To have and to exercise all powers necessary or convenient to effect the above purposes.

The foregoing paragraphs of this **ARTICLE III** and each phrase thereof shall be construed, in their broadest sense, as purposes and powers of the Company in addition to those powers specifically conferred upon the Company by law, and it is hereby expressly provided that the foregoing specific enumeration of purposes and powers shall not be held to limit or restrict in any manner the powers of the Company otherwise granted by law. Nothing herein contained, however, shall be construed as authorizing the Company to carry on the business of banking or that of a trust company, or the business of insurance.


ARTICLE IV
