#### **ARTICLE II**

# PERIOD OF DURATION

The period of duration for the Company shall be fifty (50) years unless terminated or extended by written Agreement of the members.

#### **ARTICLE III**

#### OBJECTS AND PURPOSES

The objects and purposes for which the Company is organized are:

- 1. To plan, organize and conduct reunion meetings for various affinity groups; to provide consulting and management services regarding same; to buy, sell, market, repair, build, construct, or refurbish all types of properties; to lease rent or manage all types of residential or commercial properties.

Nothing herein contained, however, shall be construed as authorizing the Company to carry on the business of banking or that of a trust company, or the business of insurance.


