GENERAL WARRANTY DEED
Joint Tenants with Right of Survivorship

STATE OF ALABAMA }
COUNTY OF SHELBY } KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Three Hundred Twenty Thousand Dollars and NO/100 (\$320,000.00)** to the undersigned grantor, in hand paid by the Grantee herein, the receipt whereof is acknowledged, I, **Fay T. Helms, an unmarried woman**, (herein referred to as **Grantor**), grant, sell, bargain and convey unto **John W. Lovvorn and Valerie R. Lovvorn**, (herein referred to as **Grantees** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

LOT 82, ACCORDING TO THE AMENDED MAP OF HICKORY RIDGE SUBDIVISION, AS RECORDED IN MAP BOOK 11, PAGE 79, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA.

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due. This property is not the homestead of the grantor nor that of her spouse.

\$ 304,000.00 of the above consideration was secured by and through the purchase money mortgage closed herewith.

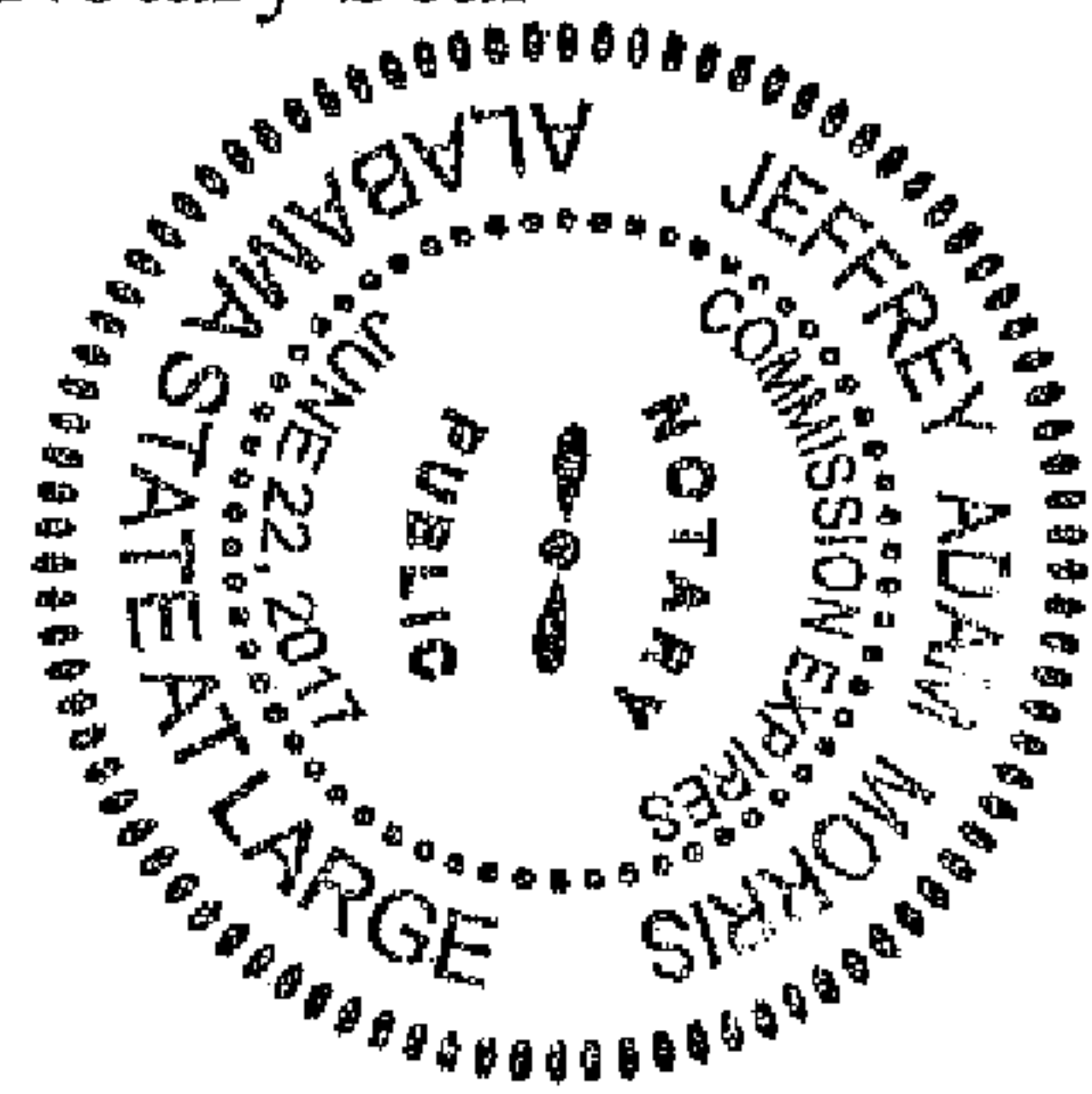
