Article I is amended to change the name of the Company to School for Amazing Kids, Weatherly, LLC.

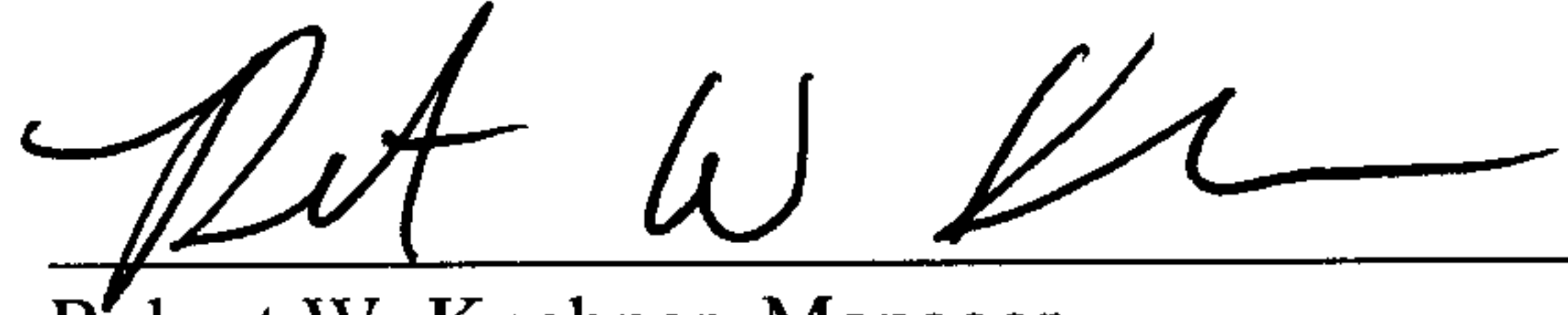
