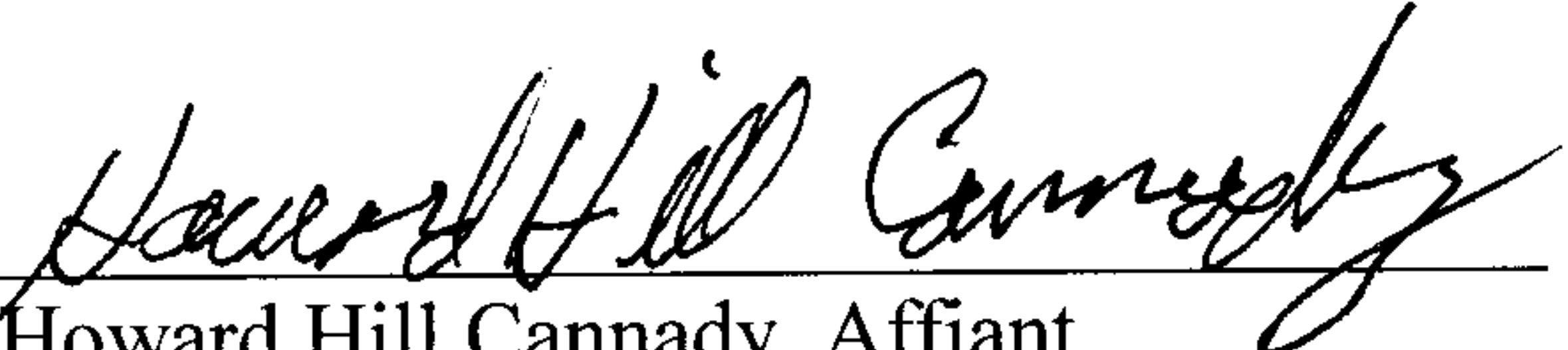
AFFIDAVIT

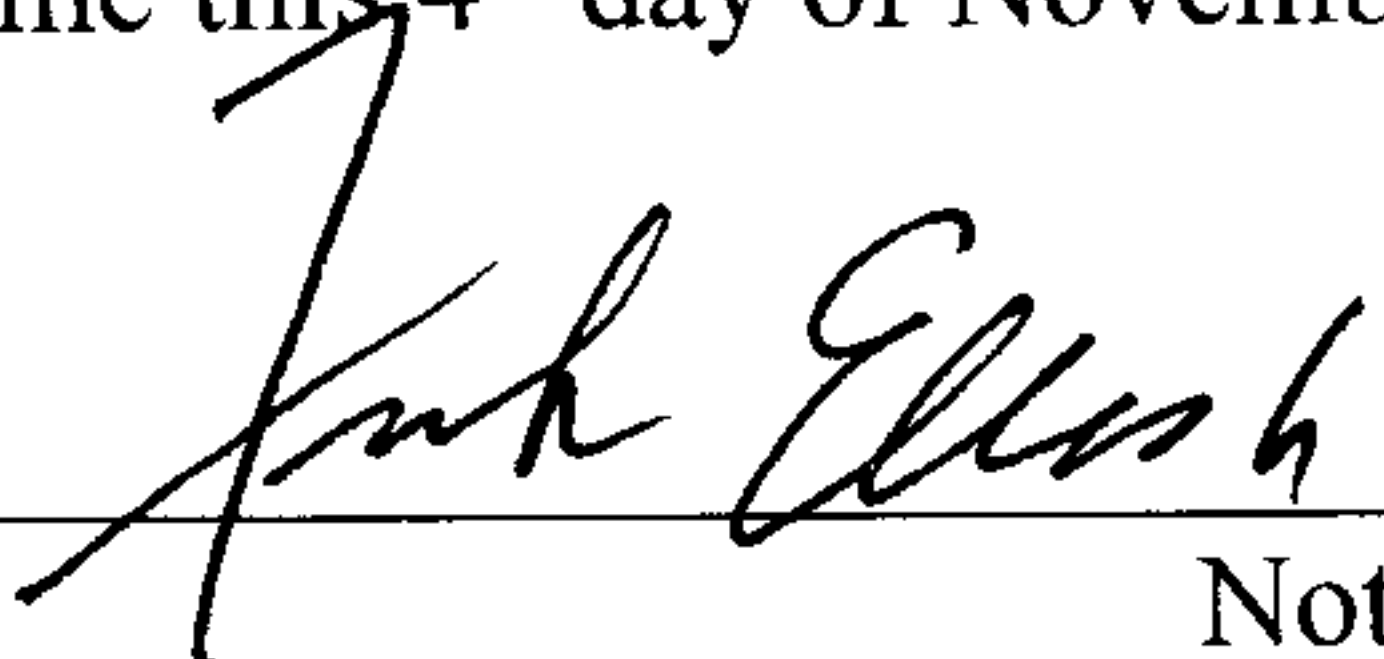

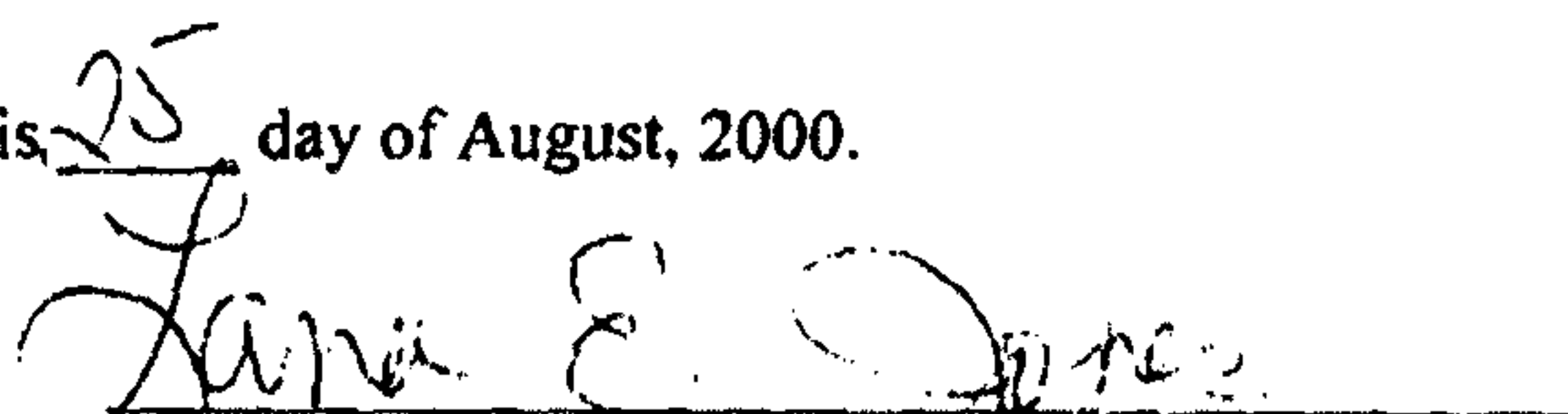
