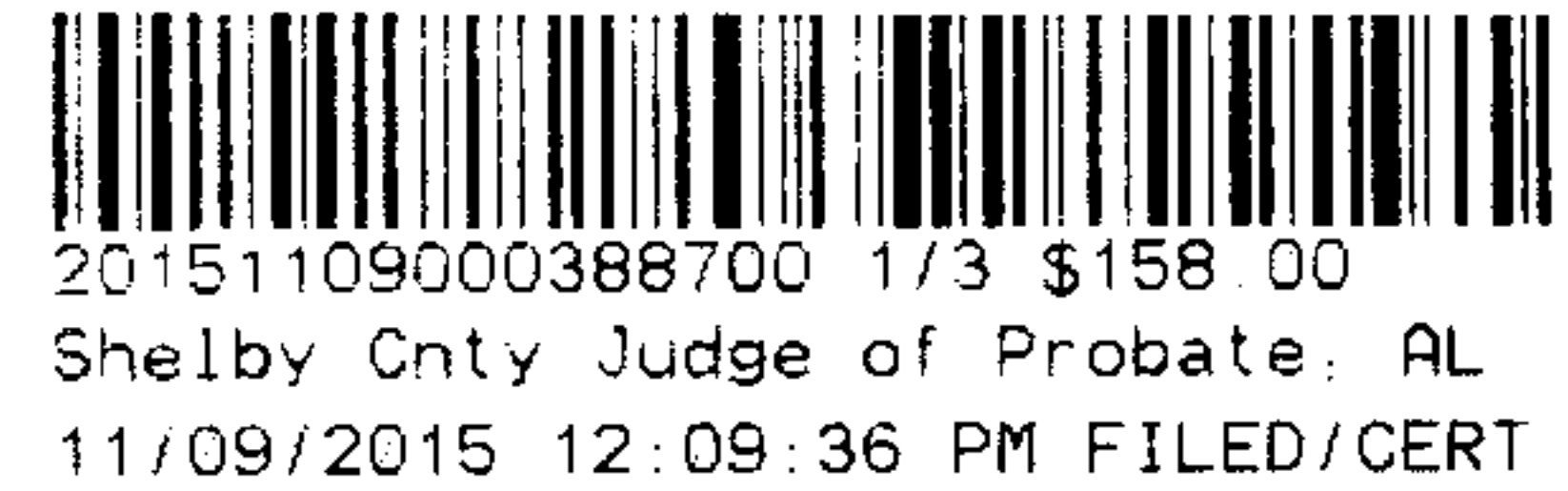

11. STATEMENT REGARDING SERIES: As provided in § 10A-51-11.02, the Company will have individual series with their own respective assets and liabilities as provided below:

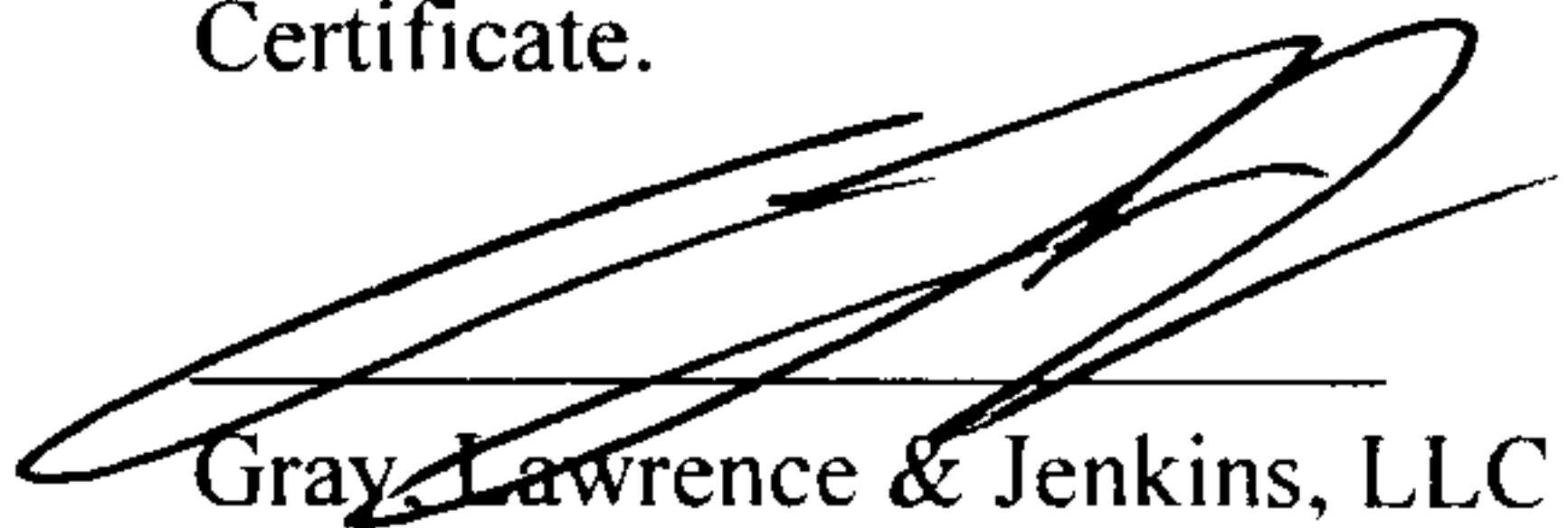

12. INDEMNIFICATION. The Company may indemnify its members, managers (if any), officer's agents and employees to the maximum extent permitted by applicable law.

13. AMENDMENT. The Company may amend, alter, change or repeal any provision in this Certificate in this manner now or subsequently provided by law and any company agreement of this Company (as such company agreement may be amended from time to time) and all rights conferred in this Certificate upon holders of membership interests are granted subject to this reservation; provided, however, no such amendment, alteration, change or repeal will be effective without approval of the members of the Company pursuant to the provisions of the Act or any company agreement in effect on the date of any such amendment.

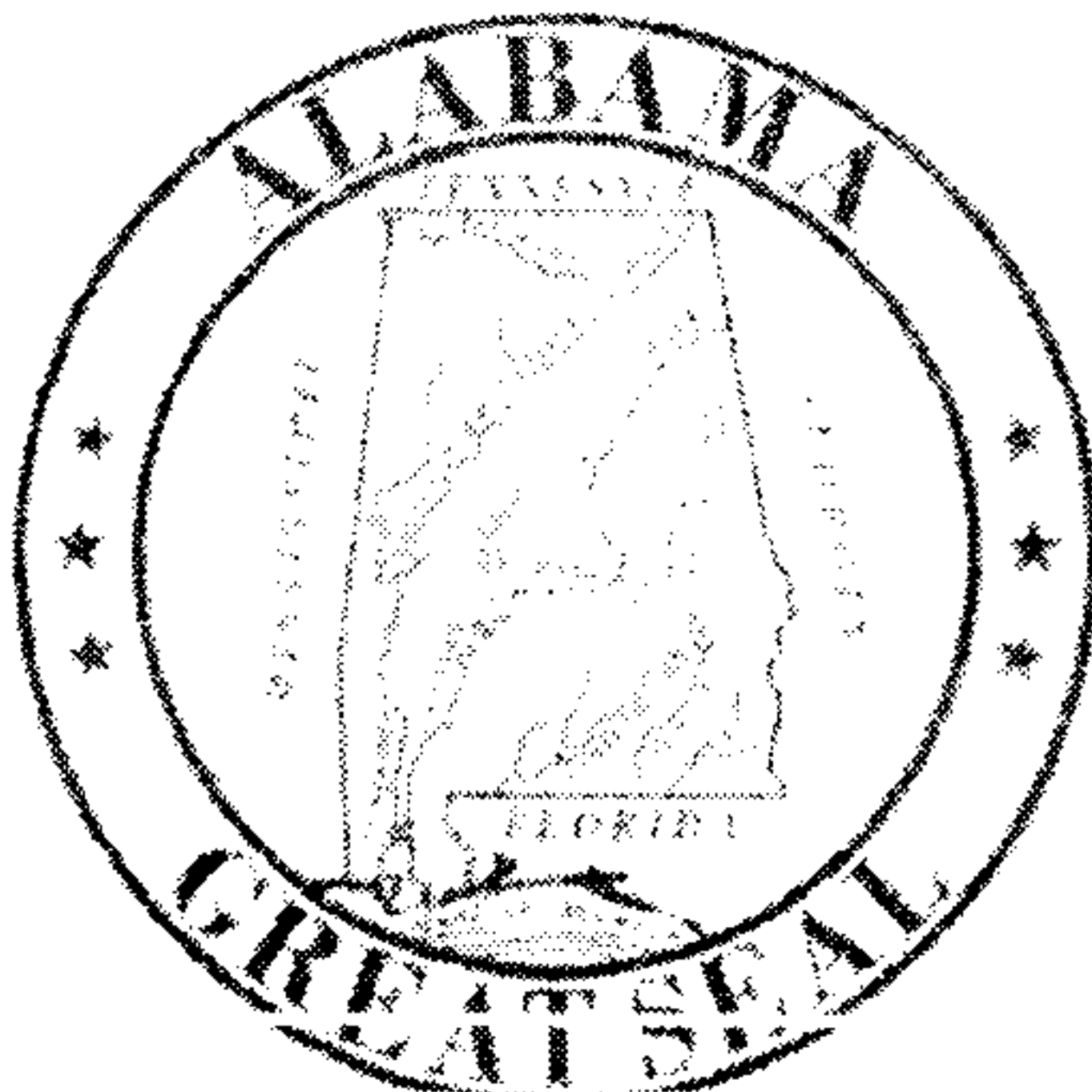
