FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of December, 2009, James Wilhoit, a married man and wife, Deborah Wilhoit, executed that certain mortgage on real property hereinafter described to Covenant Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20100111000009390, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument Number 20131220000487240, in the aforesaid Probate Office ("Transferee"); and

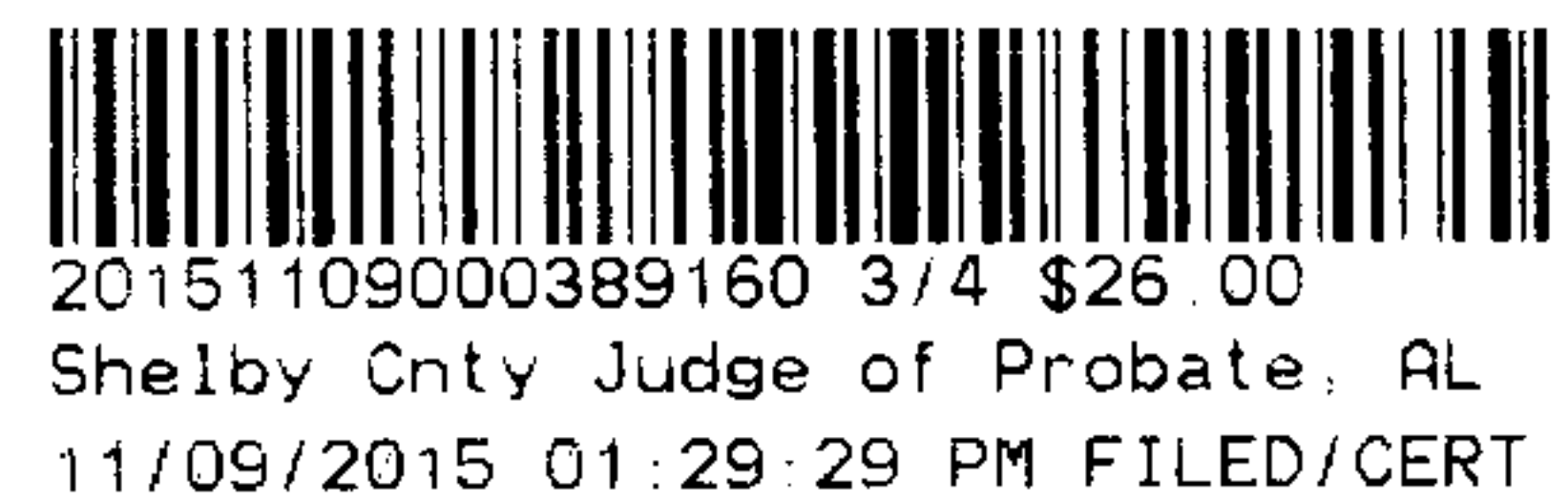

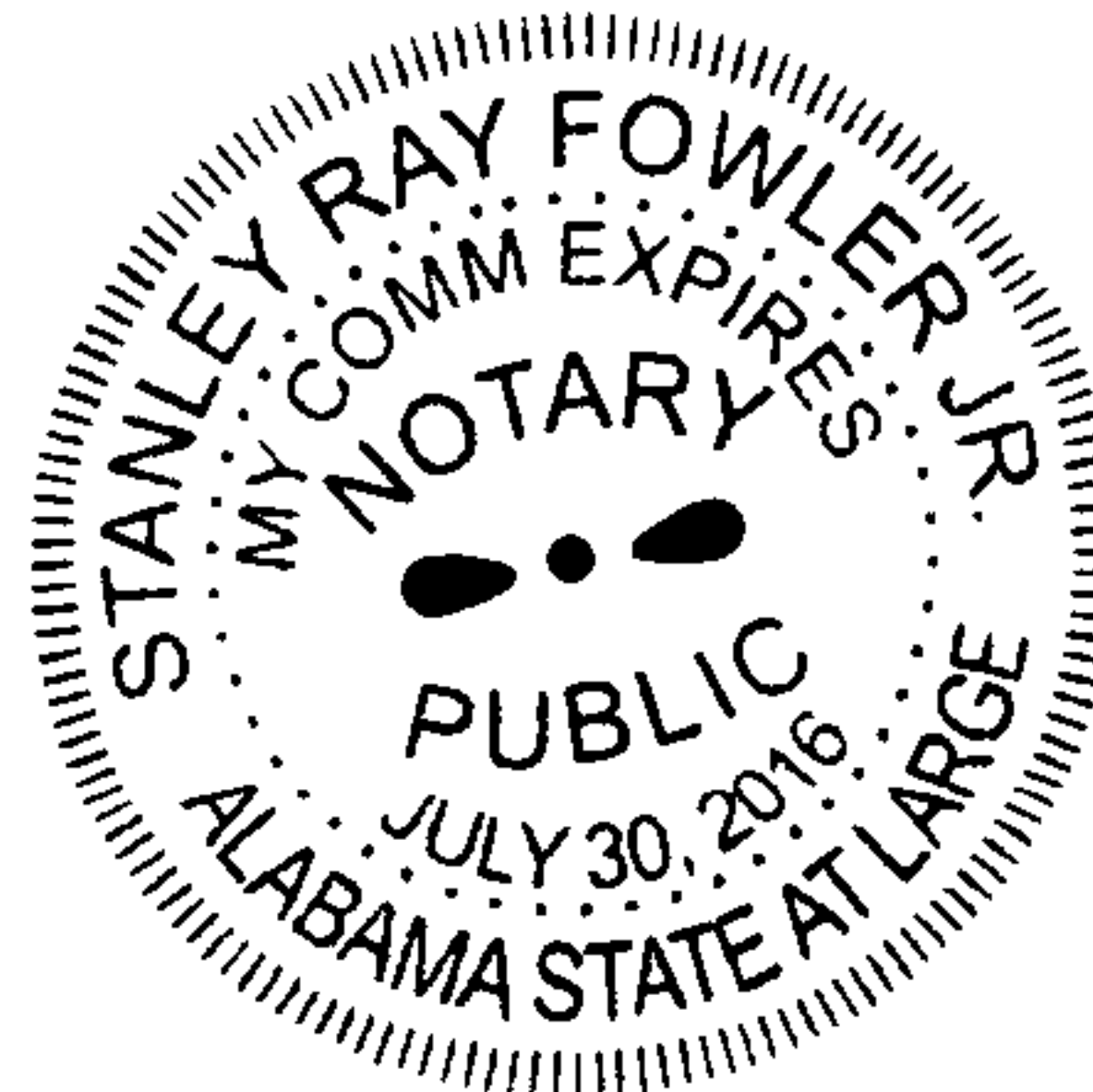
