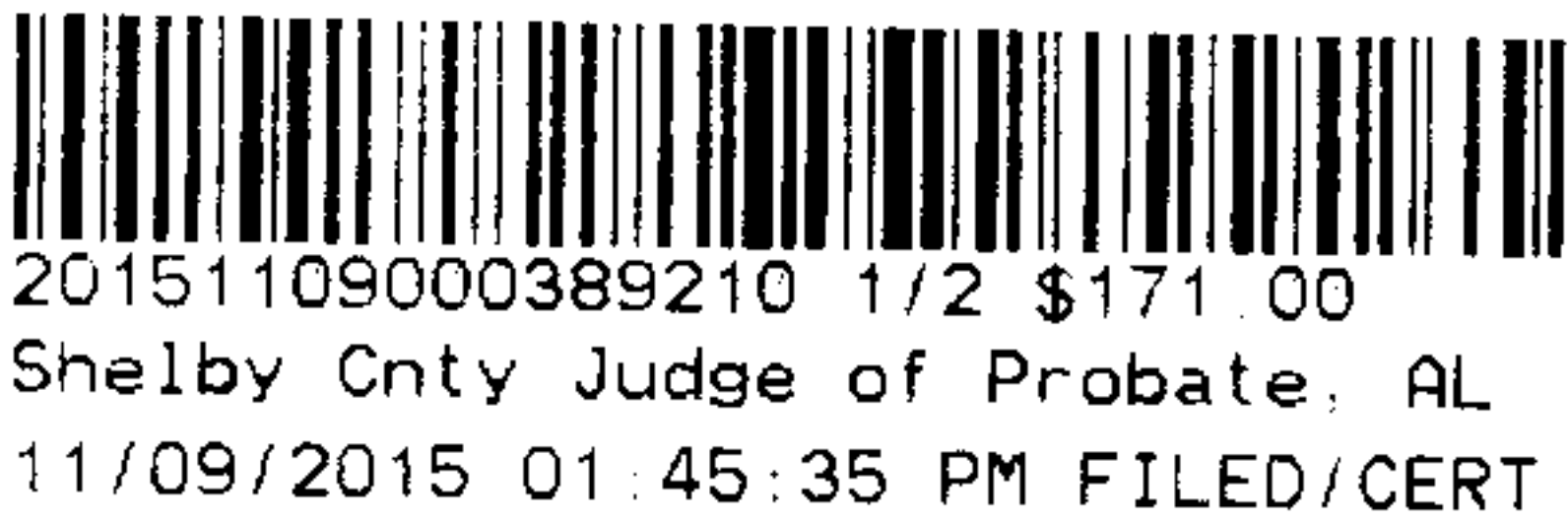

Subject to Mineral and Mining rights of record.





