MORTGAGE FORECLOSURE DEED

THIS INDENTURE, effective as of the 22 day of October, 2015 between U.S. BANK NATIONAL ASSOCIATION, as Grantor, and U.S. BANK NATIONAL ASSOCIATION, as Grantee.

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, August 22, 2005, Ann Margaret C Posada, A Single Woman, Mortgagor, did execute a certain mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for HMSV-USB Lending, LLC dba MortgageSouth, which said mortgage is recorded in Instrument No. 20050826000440620, in the Office of the Judge of Probate of Shelby County, Alabama.; and

WHEREAS, on October 22, 2015, the day on which the foreclosure sale was due to be held under the terms of said notice at 3:20 o'clock am/pm, between the legal hours of sale, said foreclosure was duly and properly conducted and U.S. BANK NATIONAL ASSOCIATION did offer for sale and sell a public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Birmingham, Alabama, the property hereinafter described; and

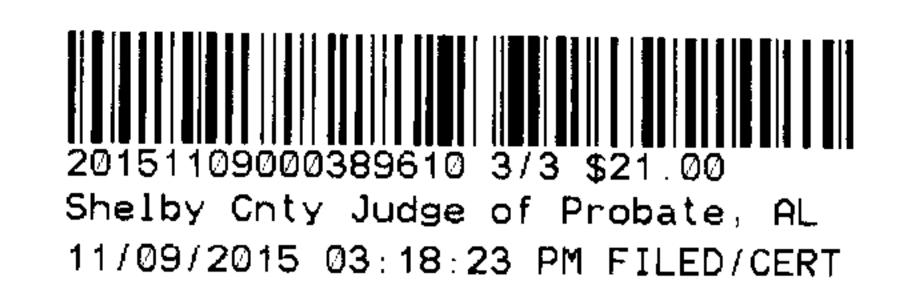
