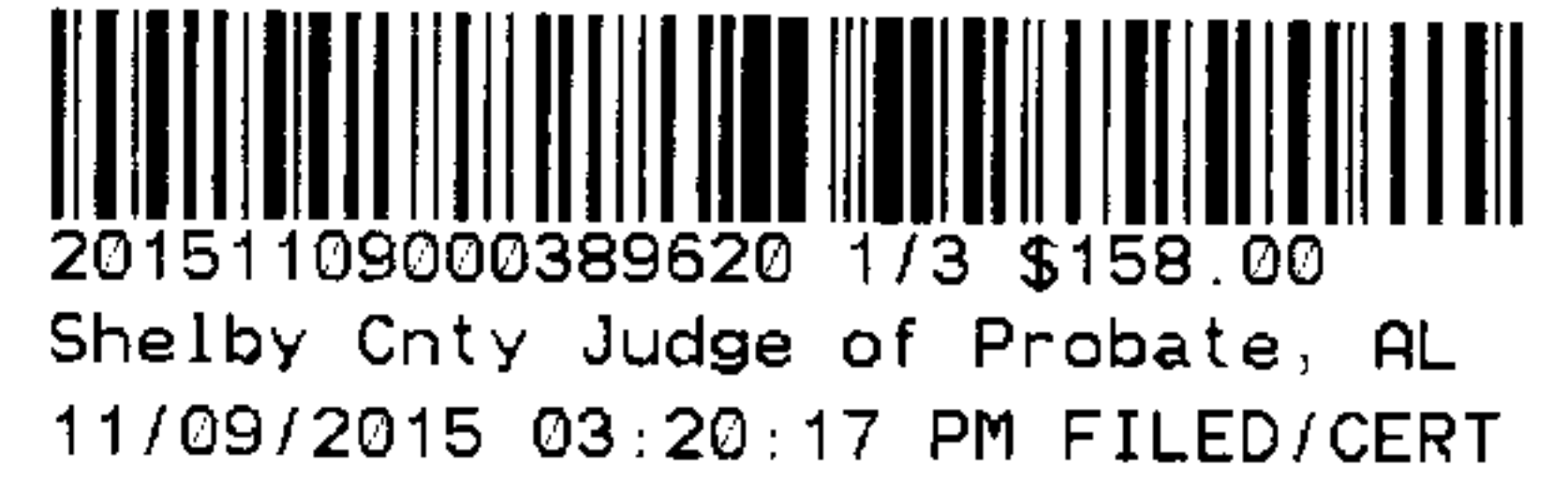


**ARTICLES OF ORGANIZATION

Shall be granted upon the majority election of the present members.

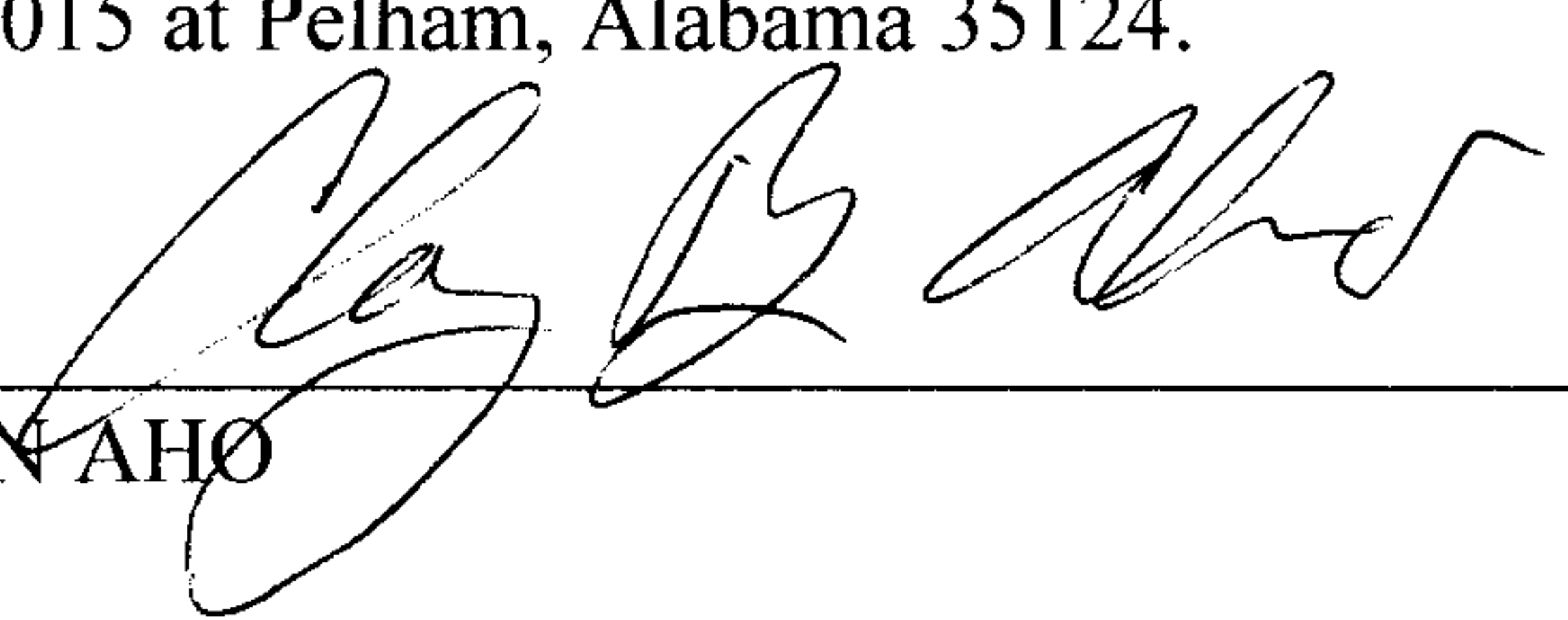
ARTICLE VIII CONTINUANCE OF THE LLC AFTER DISSOCIATION
