FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of April, 2012, Joseph E. Honeycutt, a single man and Molly M. Ketron, a single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for FirstBank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20120503000154100, said mortgage having subsequently been transferred and assigned to U.S. Bank National Association, by instrument recorded in Instrument No. 20150326000095150, in the aforesaid Probate Office ("Transferee"); and

mortgage by publication in the Shelby County Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of September 2, 2015, September 9, 2015, and September 16, 2015; and

WHEREAS, on October 28, 2015, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and U.S. Bank National Association did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, Red Mountain Title, LLC was the auctioneer which conducted said foreclosure sale and was the entity conducting the sale for the said U.S. Bank National Association; and

WHEREAS, CS Equity Partners LLC was the highest bidder and best bidder in the amount of Sixty-Five Thousand And 00/100 Dollars (\$65,000.00) on the indebtedness secured by said mortgage, the said U.S. Bank National Association, by and through Red Mountain Title, LLC as auctioneer conducting said sale for said Transferee, does hereby remise, release, quit claim and convey unto CS Equity Partners LLC all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to-wit:

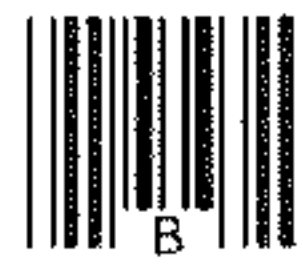
A parcel of land located in the West 1/2 of the Northwest 1/4 of Section 21, Township 21 South, Range 3 West, Shelby County, Alabama, as described in Deed Book 316, Page 744 in the Shelby County Judge of Probate Office, more particularly described as follows:

Commence at the SE corner of the Northwest 1/4 of the Northwest 1/4 of said Section 21; thence run South 78 degrees 25 minutes 17 seconds West a distance of 170.3 feet to an iron pin on the Westerly Right Of Way of Shelby County Hwy. Number 17; thence run South 61 degrees 41 minutes 27 seconds West a distance of 239.8 feet to an iron pin; thence run North 28 degrees 18 minutes 33 seconds West a distance of 105.0 feet to an iron pin and the point of beginning; thence continue last course a distance of 91.5 feet to an iron pin; thence run North 47 Degrees 16 minutes 51 seconds East a distance of 328.2 feet to an iron pin on the Westerly Right Of Way of Shelby County Hwy Number 17; thence run Southeasterly along said Right of Way a distance of 154.0 feet to an iron pin; thence run South 56 degrees 31 minutes 35 seconds a distance of 277.4 feet to the point of beginning. There is reserved a 20 foot Easement for the purpose of ingress and egress along the Southeasterly line of the above described parcel.

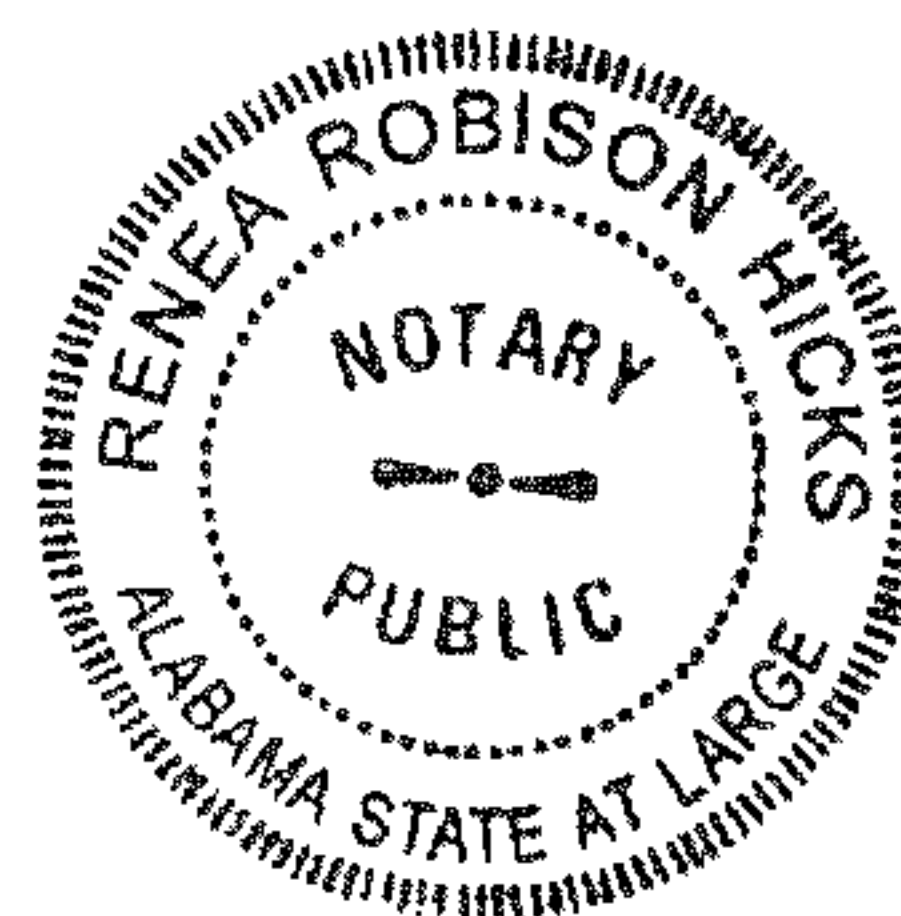
