

MEMORANDUM OF RIGHT OF FIRST REFUSAL

THIS MEMORANDUM OF RIGHT OF FIRST REFUSAL (hereinafter, as amended from time to time in accordance with the terms hereof, "this Memorandum") is entered into as of October 27, 2015, by and between Southern Electric Generating Company and Alabama Property Company (collectively, "Southern") and Jesse Creek Mining, LLC ("Jesse Creek").

Recitals

- A. Southern and Jesse Creek have entered into a Right of First Refusal agreement dated simultaneously herewith (the "Agreement") that grants Jesse Creek a right of first refusal to lease certain real estate described on Exhibit A thereto, located on Shelby County, Alabama (the "Property"), subject to the terms and conditions of the Agreement.
- B. The parties are desirous of recording this Memorandum to provide record notice of the Right of First Refusal granted under the Agreement.

Agreement

- NOW, THEREFORE, in consideration of the foregoing recitals and to induce Southern and Jesse Creek to enter into the Agreement, and for other good and valuable consideration in hand paid by Jesse Creek to Southern, the receipt and sufficiency of which is hereby acknowledged, Southern and Jesse Creek hereby agree as follows:
- 1. The name of the party receiving the Right of First Refusal under the Agreement is Jesse Creek Mining, LLC. The names of the parties granting the Right of First Refusal under the Agreement are Southern Electric Generating Company and Alabama Property Company.
- 2. A specific legal description of the Property is attached hereto as Exhibit A and B. The Term of the Right of First Refusal begins on September 1, 2016 and ends on August 31, 2019.
- 3. This Memorandum is executed for the purpose of giving notice of the existence of the Right of First Refusal under the Agreement. If a conflict between the provisions of the Agreement and this Memorandum shall occur, the provisions of the Agreement shall govern.

4. This Memorandum may be executed in any number of counterparts, each of which so executed shall be deemed an original, but all such counterparts shall together constitute but one and the same instrument.

IN WITNESS WHEREOF, each of the parties hereto has caused this Memorandum to be executed in its names and on its behalf by its officers thereunto duly authorized as of the date first set forth above and to be recorded in the Office of the Judge of Probate of Shelby County, Alabama.


