### FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on April 25, 2005, to-wit: Brian S. Greener and wife, Christa Greener, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for Accredited Home Lenders, Inc., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on May 5, 2005, in Instrument No. 20050505000215910, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to HSBC Bank USA, National Association, as Indenture Trustee of the FBR Securitization Trust 2005-1, Callable Mortgage-Backed Notes, Series 2005-1, by assignment recorded July 23, 2014, in Instrument No. 20140723000225840, Probate Records of Shelby County, Alabama; and

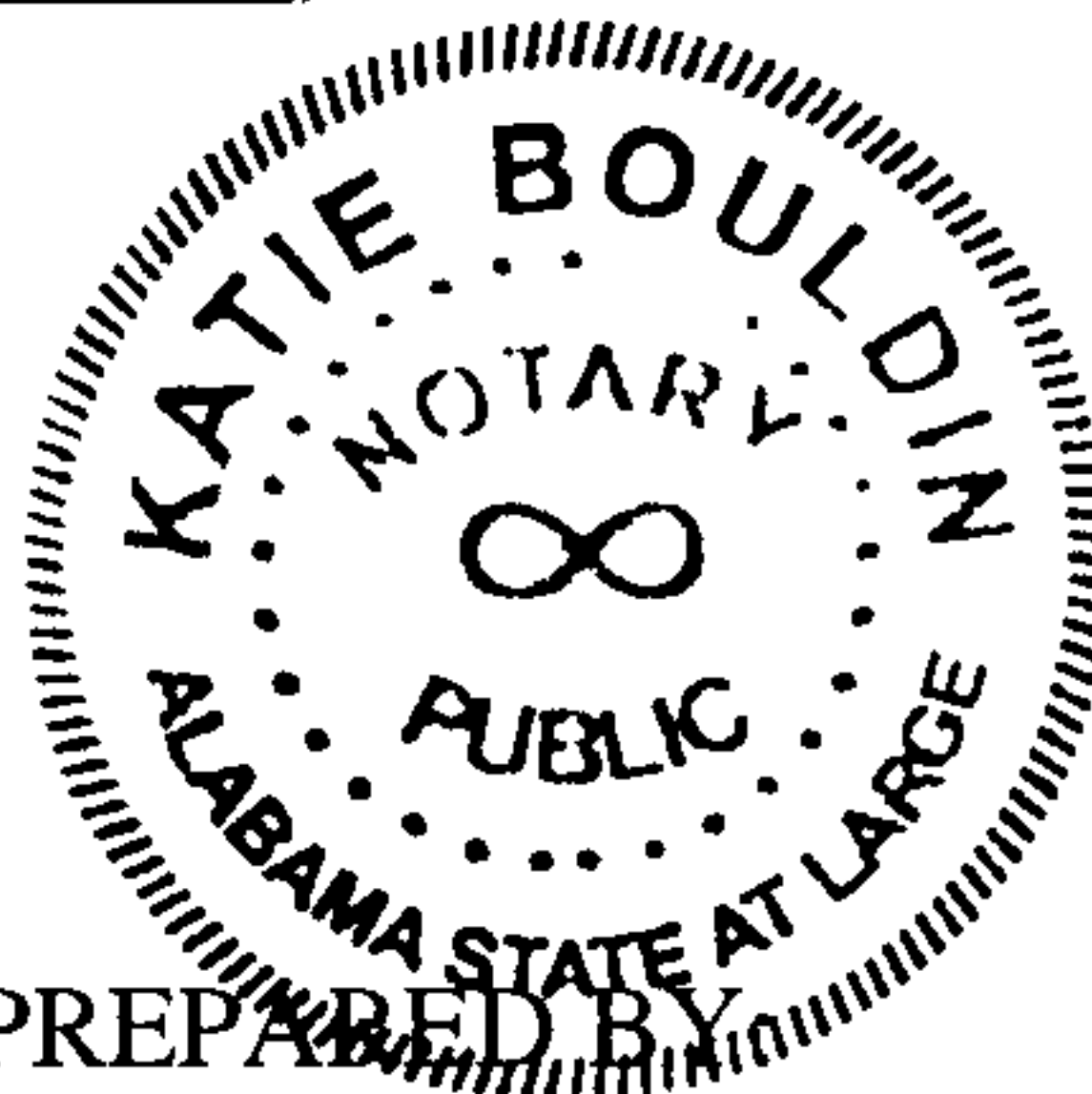

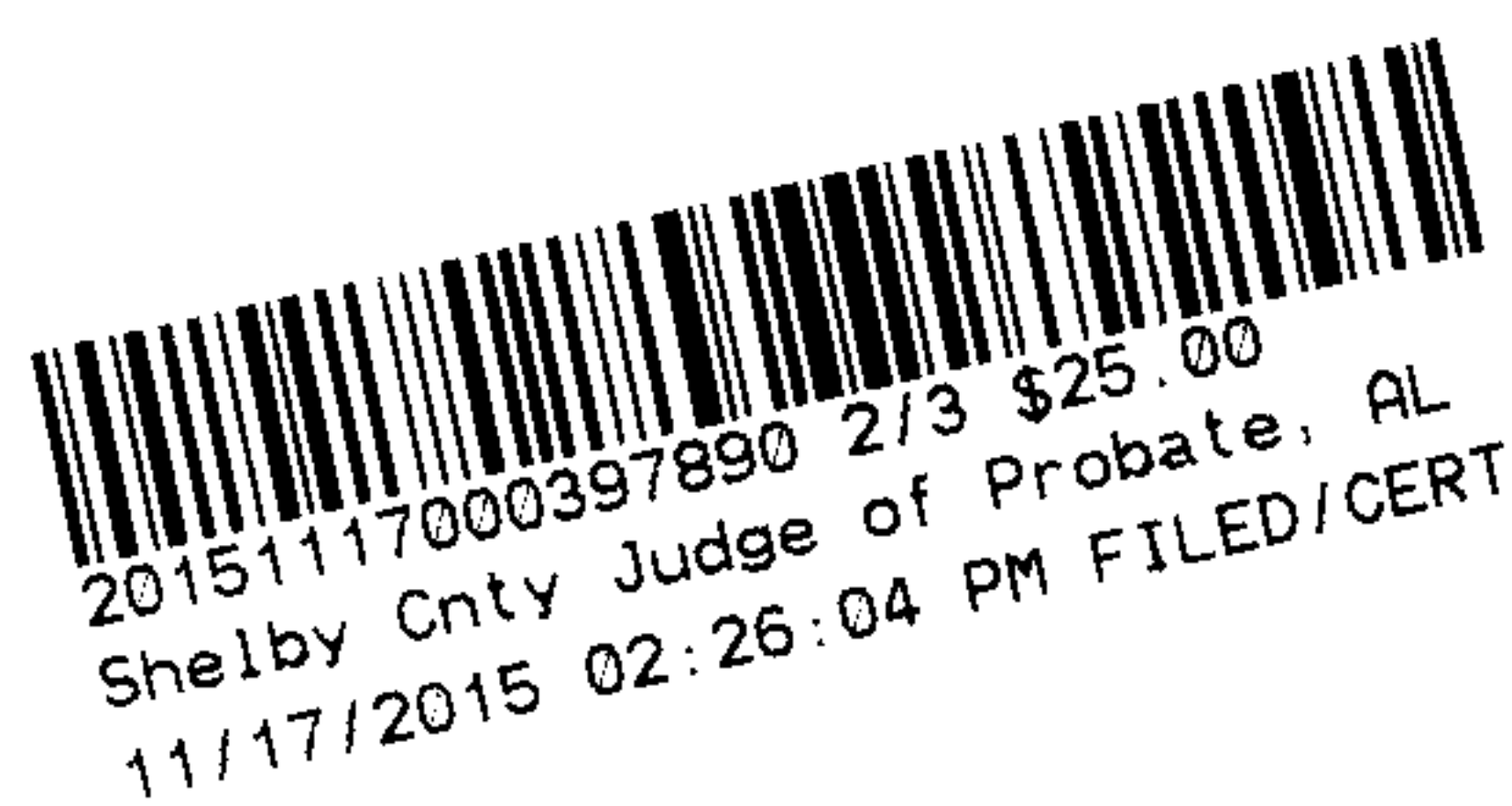
