DEFAULT JUDGMENT AND FINAL ORDER

WHEREAS, the Motion of The Bank of New York Mellon FKA The Bank of New York, as Trustee for the Certificateholders of CWMBS, Inc., Alternative Loan Trust 2003-4CB, Mortgage Pass-Through Certificates, Series 2003-12 (hereinafter, "BONY" or "Plaintiff") for Default Judgment against Defendants Richard Allen Erwin (hereinafter, "Mr. Erwin") and Robin M. B. That the Mortgage, recorded at Instrument No. 20030203000062640, Judge of Probate of

Shelby County, Alabama, is hereby declared a valid, enforceable, first priority secured position

on the Property.
