\$145,319.00 of the above-recited consideration is being paid with a purchase money mortgage being recorded simultaneously herewith.

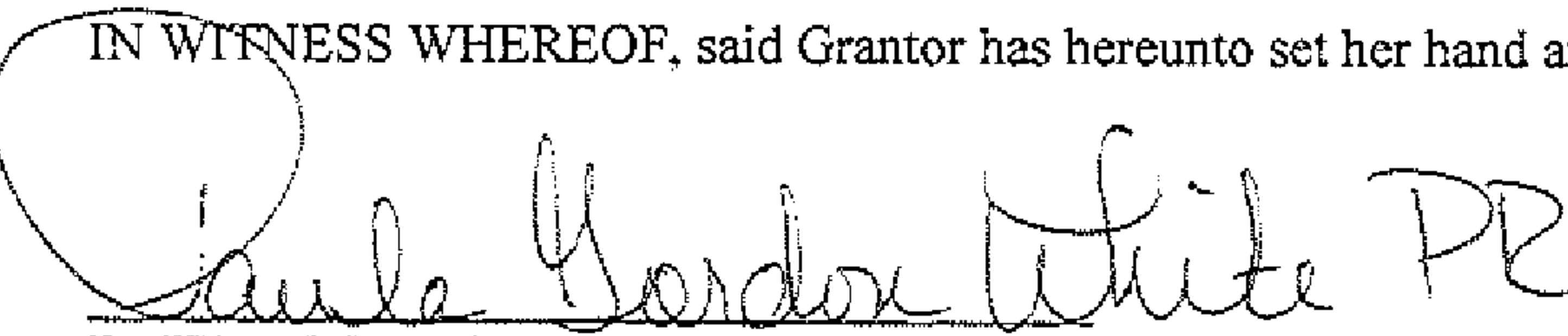
Elaine Gordon predeceased Paul Nash Gordon, having died on, to-wit: 10/13/2012.

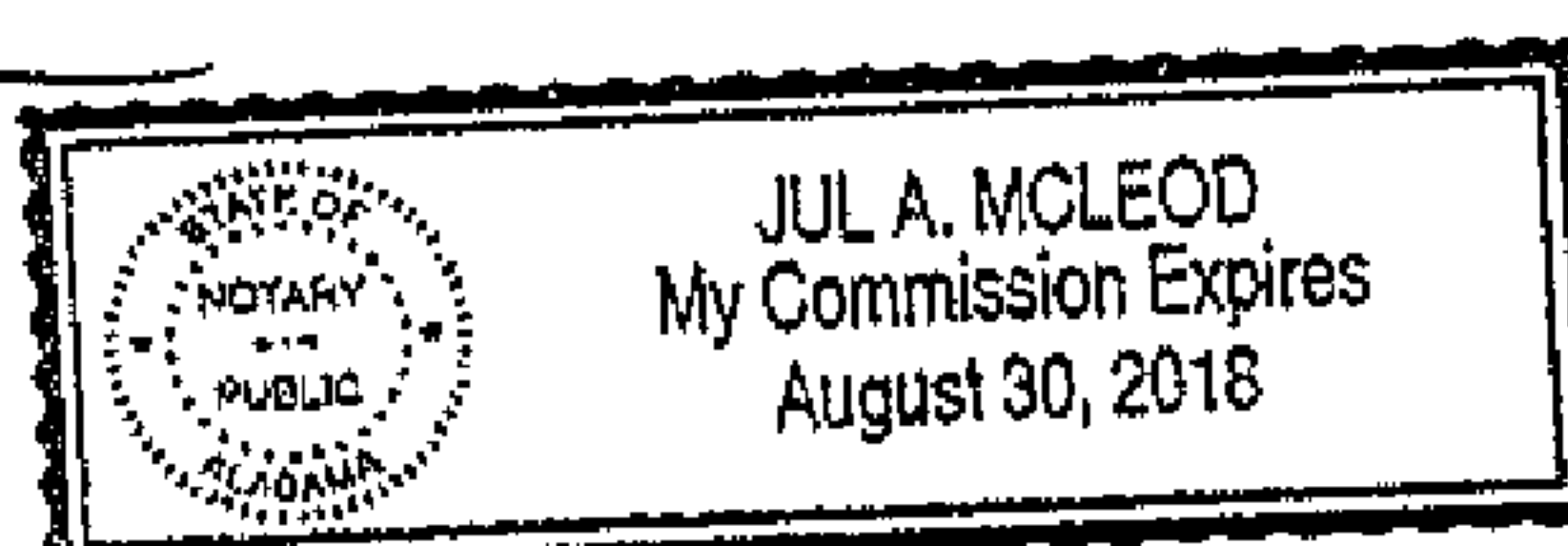
