WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **Five Hundred Twenty Thousand and 00/100 Dollars (\$520,000)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

John A. Lucas, III, and his wife, Beverly W. Lucas

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Constantine J. Pihakis and Jennifer L. Pihakis

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

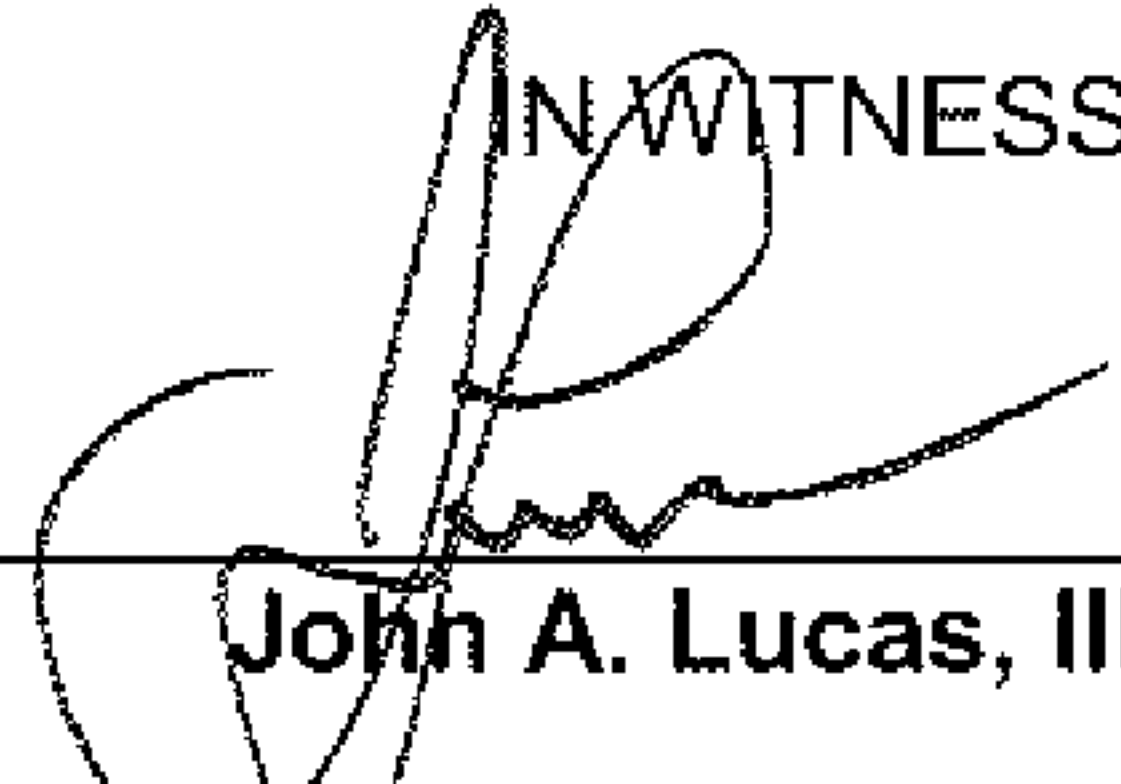
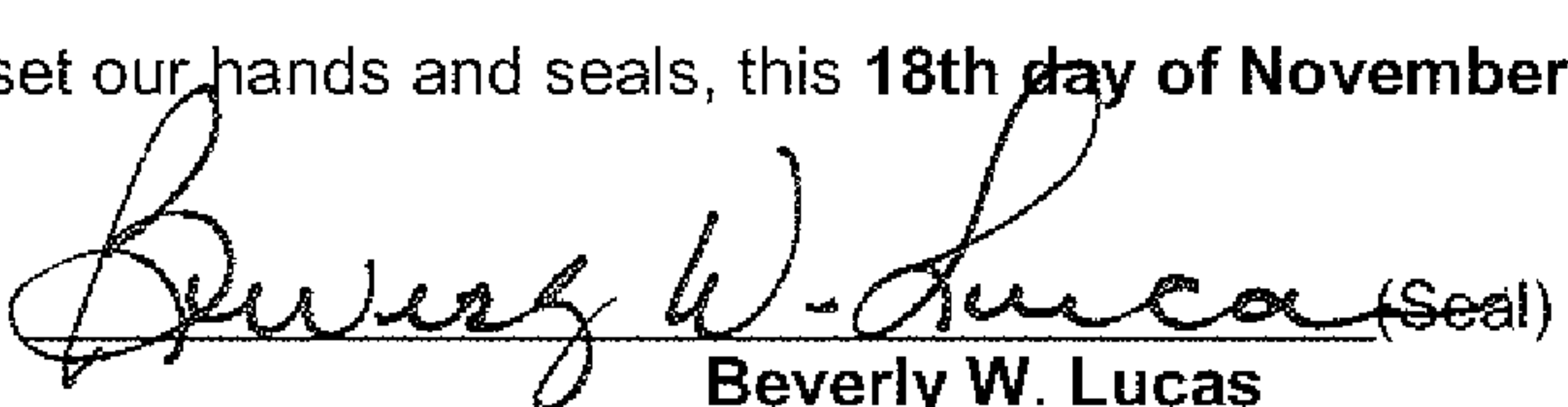

Subject to: (1) 2016 ad valorem taxes not yet due and payable;
(2) all mineral and mining rights not owned by the Grantors; and
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.

TO HAVE AND TO HOLD unto Grantees as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

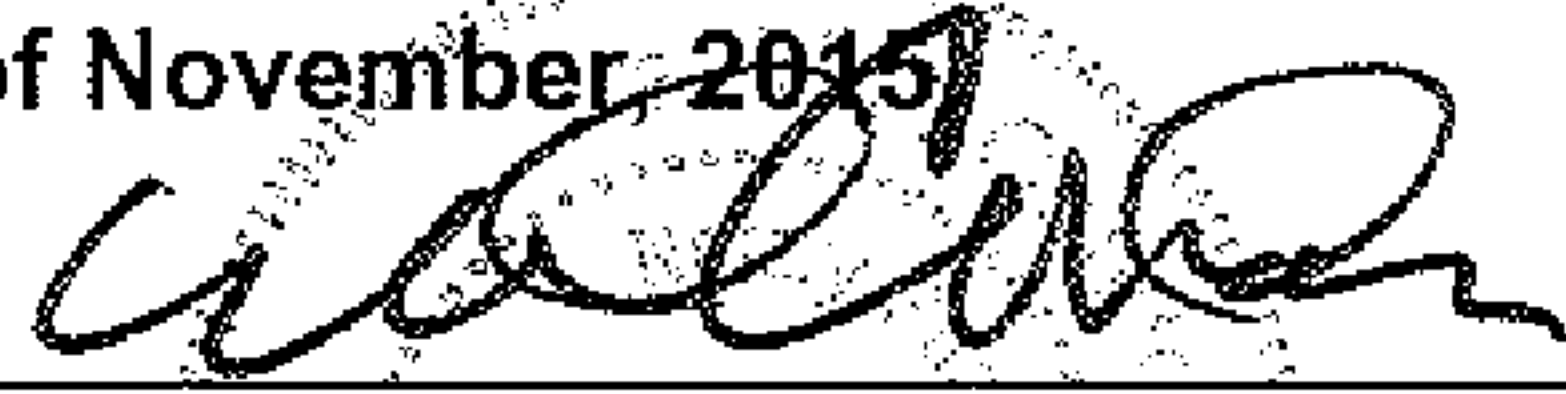

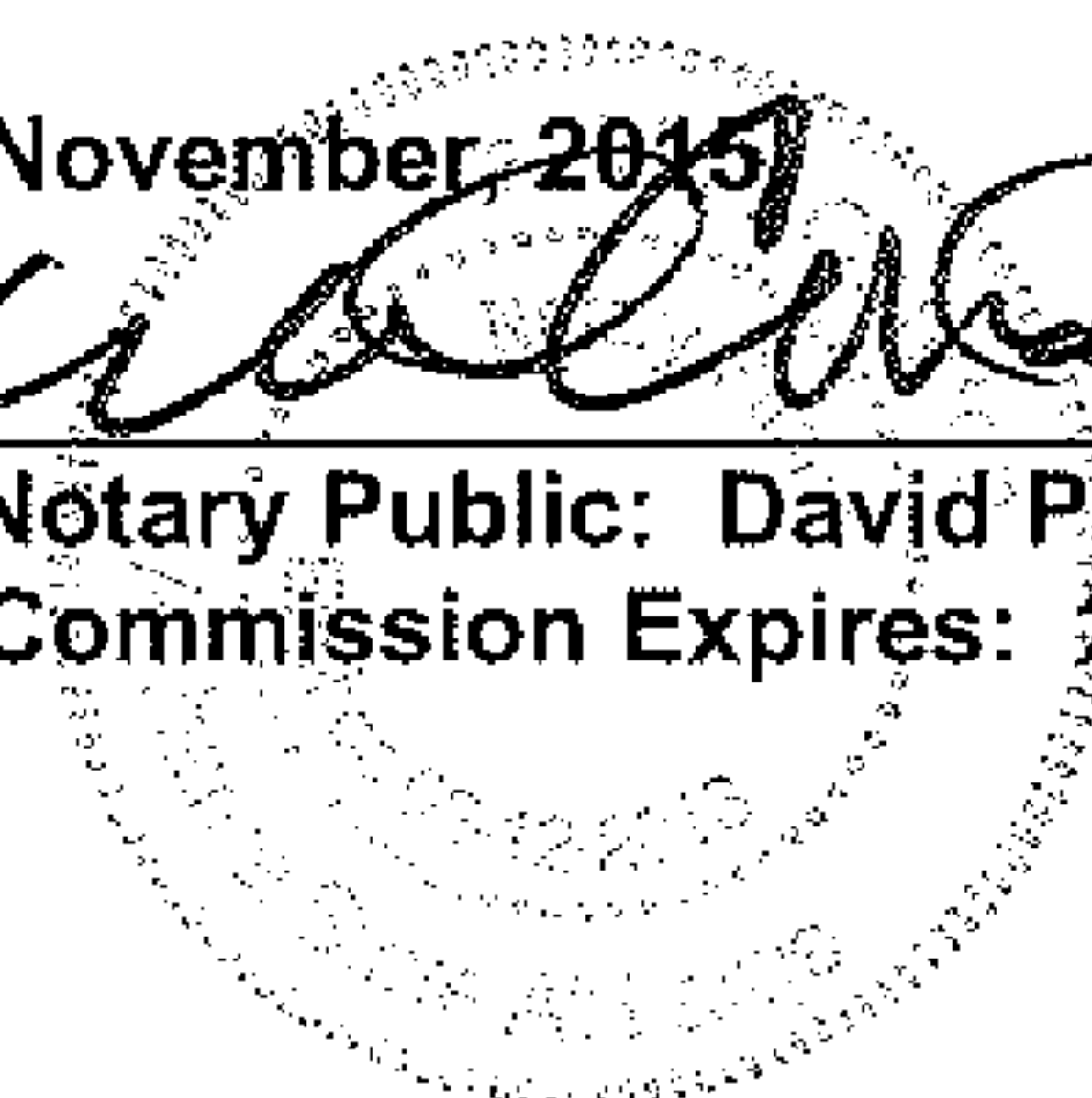
