Barbero, a married man*** (herein referred to as ***Grantor***) grant, bargain, sell and convey unto ***Russell C. Barbero and Anne Barbero*** (herein referred to as ***Grantees***), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:


SUBJECT TO:



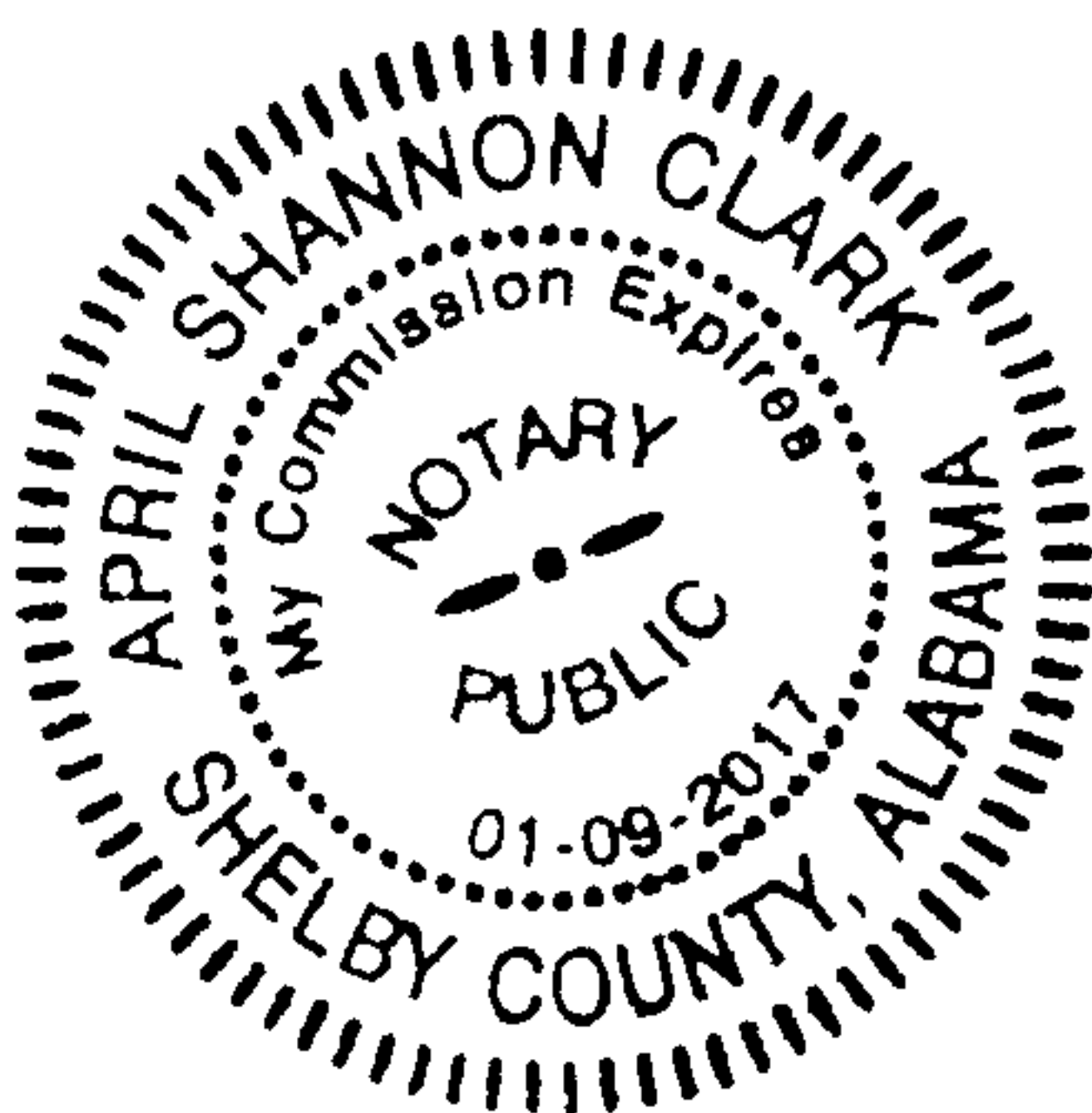
