KNOW ALL MEN BY THESE PRESENTS, That in consideration **FIVE THOUSAND AND NO/00 DOLLARS (\$5,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Russell C. Barbero, a married man** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **Russell C. Barbero and Anne Barbero** (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:

Lot 339, according to the Survey of Alabama Power Company Recreational Cottage Site, Sector 1, as recorded in Map Book 21, Page 96 A-C in the Probate Office of Shelby County, Alabama.

SUBJECT TO:



