FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on June 29, 2010, to-wit: Martha A. Evans, a single person, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for Henger Rast Mortgage Corporation, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on July 6, 2010, in Instrument No. 20100706000214340, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, National Association, by assignment recorded May 30, 2013 in Instrument No. 20130530000220710, Probate Records of Shelby County, Alabama; and

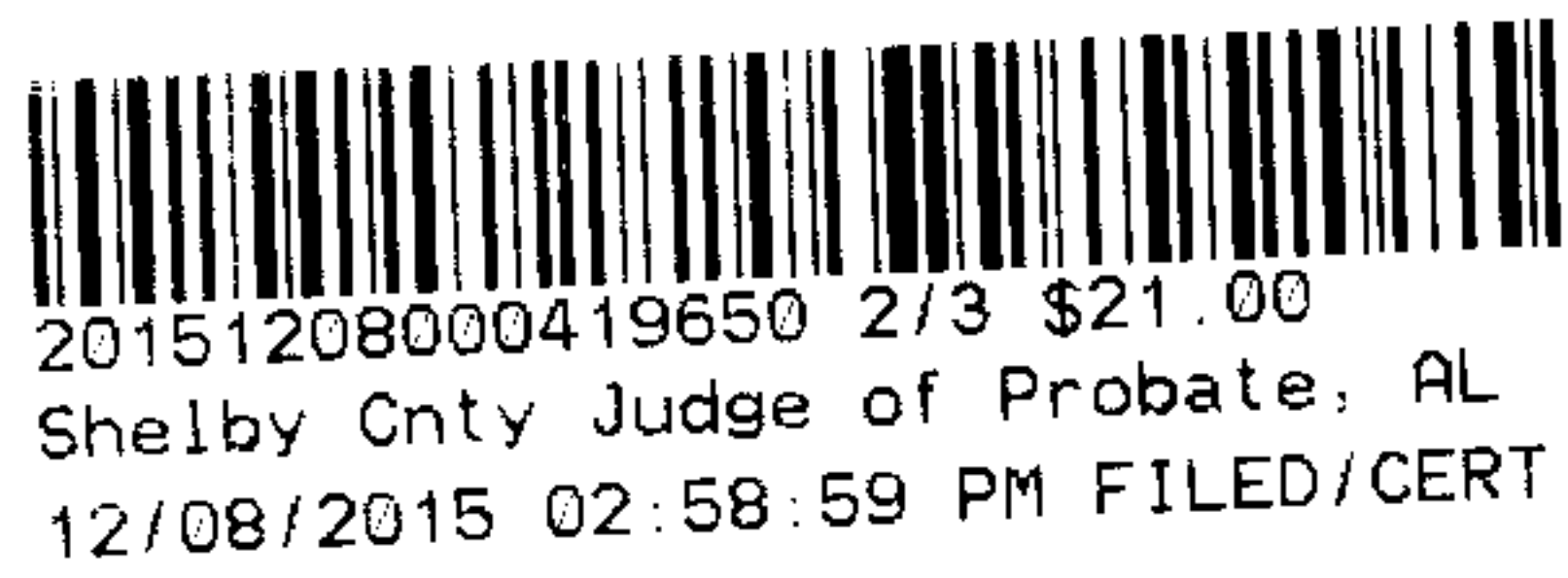

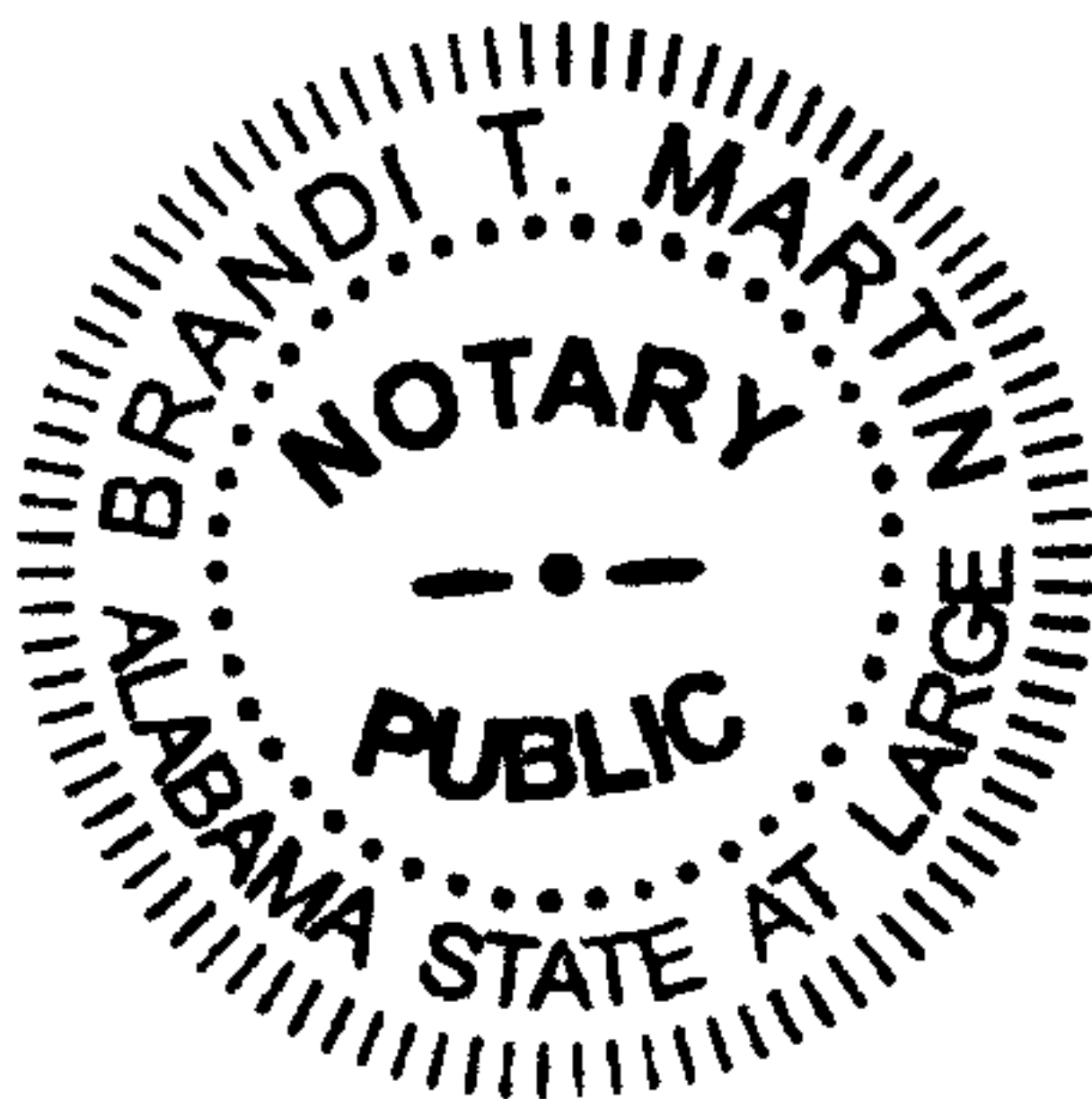
