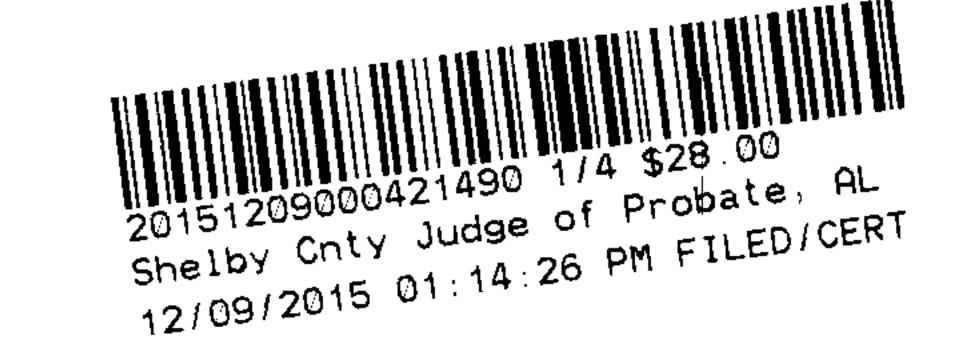

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, on to-wit, August 30, 2006, Alfred W. Givens, Jr. and Rebecca A. Givens, husband and wife ("Mortgagors"), executed a certain mortgage ("Mortgage") to Mortgage Electronic Registration Systems, Inc. solely as nominee for Hamilton Mortgage Corporation said Mortgage being recorded October 11, 2006 in Instrument Number 20061011000503180, in the Office of the Judge of Probate of Shelby County, Alabama; assigned to Green Tree Servicing LLC by instrument recorded in Instrument Number 20130613000241960 in the Office of the Judge of Probate of Shelby County, Alabama.
