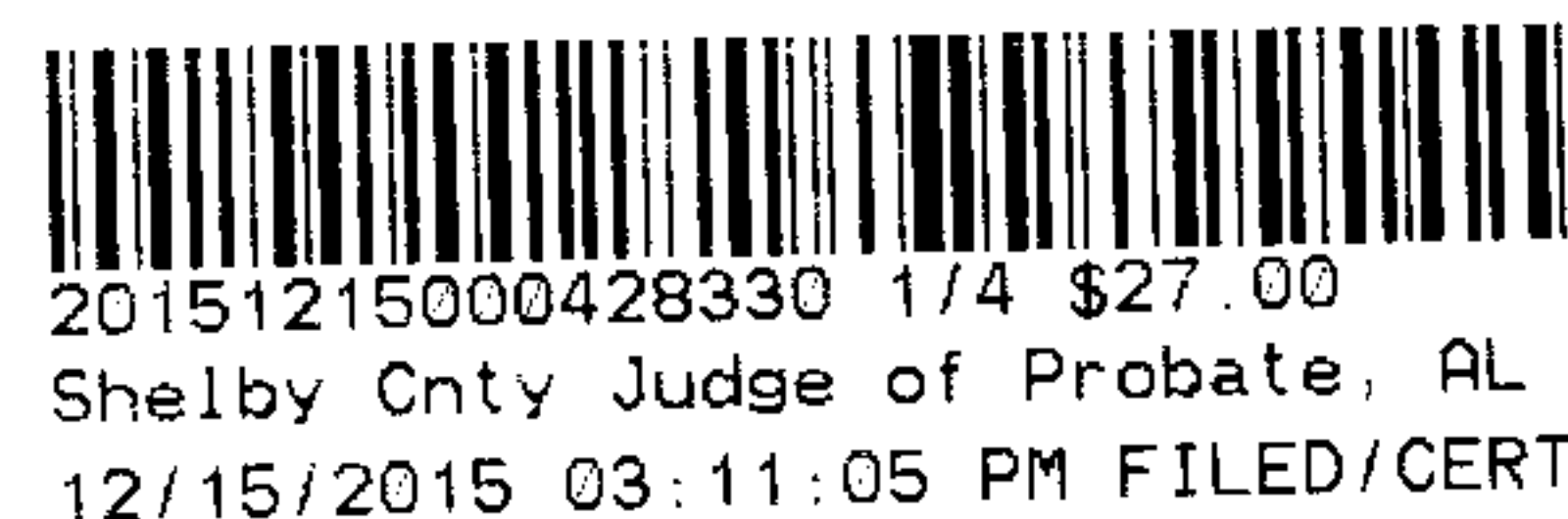


MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS: That Leslie A Sorrell, an unmarried woman did, on to-wit, June 1, 2007, execute a mortgage to Mortgage Electronic Registration Systems, Inc. as nominee for Countrywide Home Loans, Inc dba America's Wholesale Lender, which mortgage is recorded in Instrument # at 20070810000375970 on August 10, 2007, in the Office of the Judge of Probate of Shelby County, Alabama, and secured indebtedness having been transferred to Nationstar Mortgage LLC.
