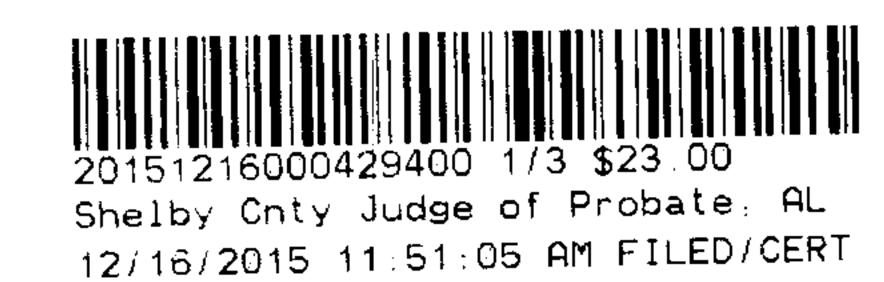
MORTGAGE FORECLOSURE DEED
