KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 9th day of January, 2006, Eddie D. Pope and Cathy S. 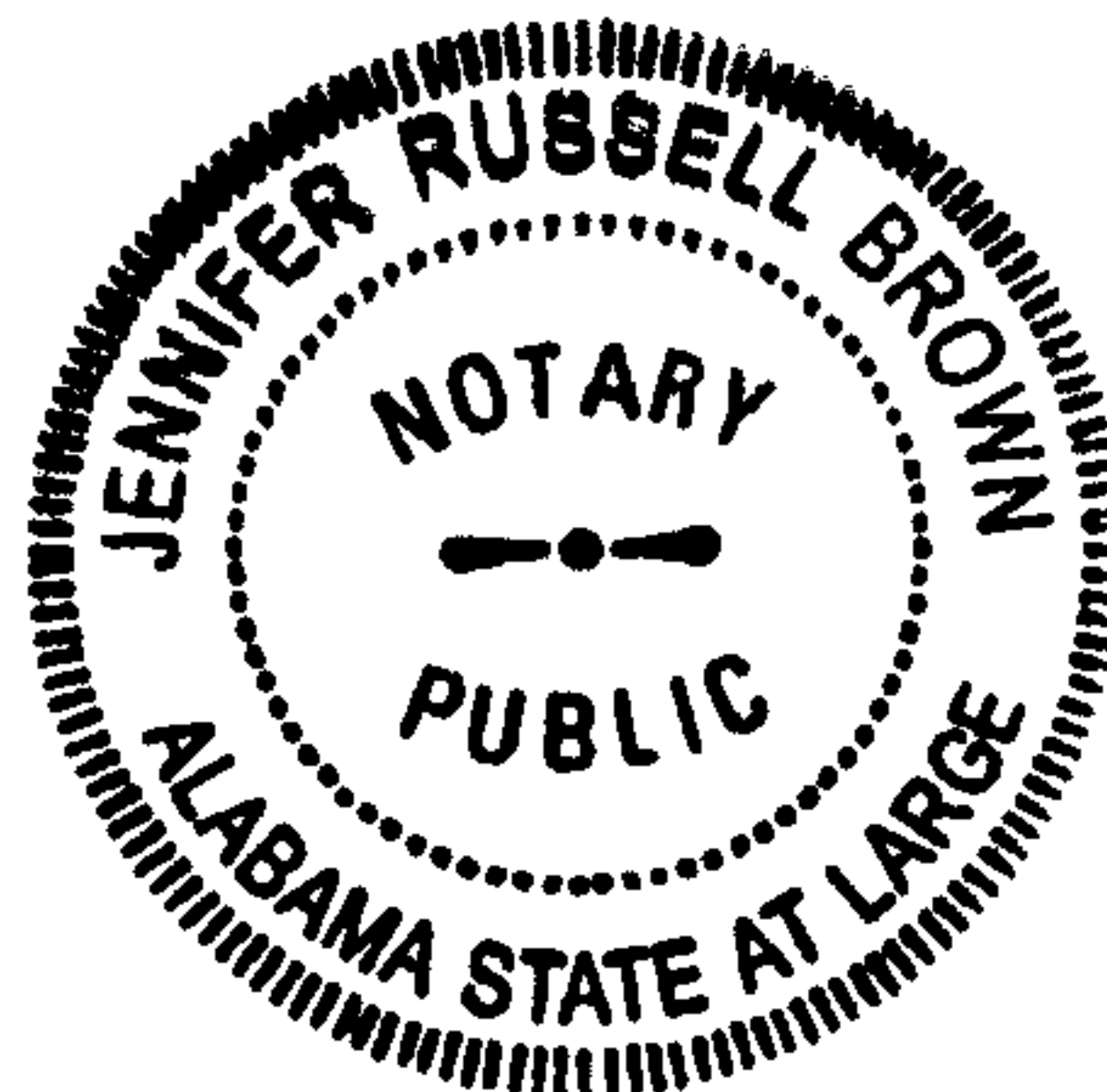
