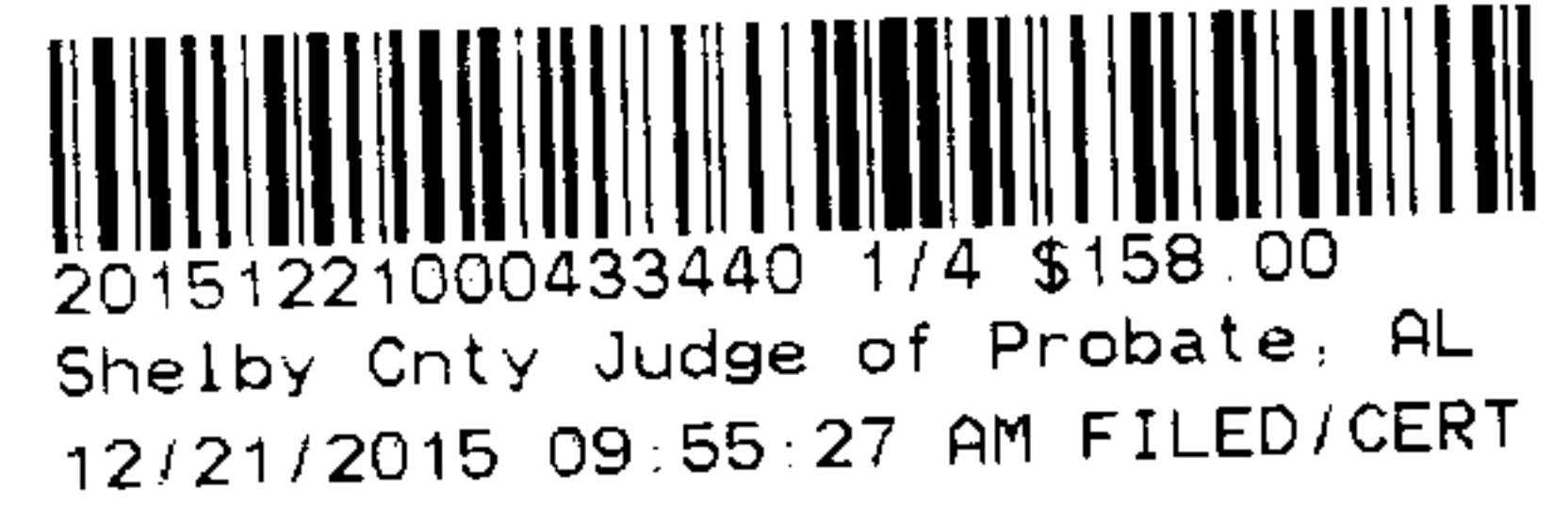


**ARTICLES OF ORGANIZATION
OF
120 SHADY ACRES, LLC**



The undersigned, being a natural person of at least 18 years of age and acting as the Organizer of the Limited Liability Company hereby being formed under the Alabama Limited Liability Company Law, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

120 SHADY ACRES, LLC

SECOND: The term of existence of the Limited Liability Company shall be perpetual, unless the Limited Liability Company is sooner terminated by the occurrence of an event set forth in the Operating Agreement.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Alabama Limited Liability Company Law, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The street address of the initial registered office of the Limited Liability Company in Alabama is 120 Shady Acres Road, Alabaster, AL, 35007, and the name of the initial registered agent of the Limited Liability Company to whom process may be sent in Alabama at that address is Jerry D. Bennett.

FIFTH: The principal office of the Limited Liability Company is 120 Shady Acres Road, Alabaster, AL, 35007.

SIXTH: The Limited Liability Company will be operated by the Members, and no manager will be appointed. The names and addresses of the Members are: JERRY D. BENNETT, having an address at 120 Shady Acres Road, Alabaster, AL, 35007, and CYNTHIA R. BENNETT, having an address at 120 Shady Acres Road, Alabaster, AL, 35007.

SEVENTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

EIGHTH: The remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion,

bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

NINTH: The name and business address of the Organizer of the Limited Liability Company is: Jerry D. Bennett, Alabaster, AL, 35007.


TENTH: The names and addresses of the Members of the Limited Liability Company are: JERRY D. BENNETT, having an address at 120 Shady Acres Road, Alabaster, AL, 35007, and CYNTHIA R. BENNETT, having an address at 120 Shady Acres Road, Alabaster, AL, 35007.


ELEVENTH: At the date of filing of these Articles of Organization, the Limited Liability Company has two Members.

TWELFTH: The Limited Liability Company does not have the power to expel a Member.

THIRTEENTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.




**CONSENT TO APPOINTMENT
