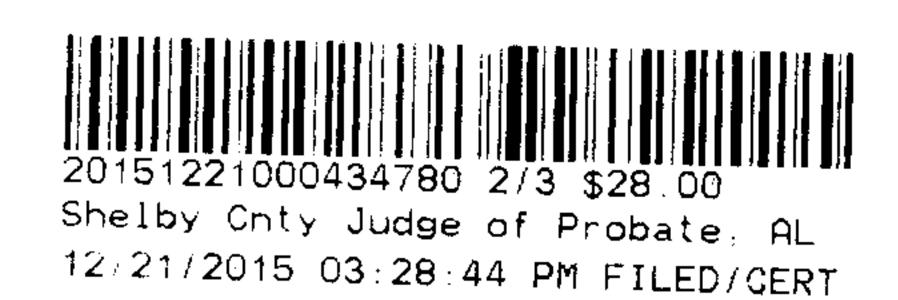
## Subject to:
