



MEMORANDUM OF LEASE AGREEMENT

This Memorandum of Lease Agreement ("Memorandum") is entered into this 4π day of 2eC, 2015, between Fyler Oil, LLC, a Kansas limited liability company, and LCF, LLC, a Kansas limited liability company (together, "Landlord"); and Bama-1RE, LLC, a Kansas limited liability company ("Tenant"), upon the following terms.

- 1. <u>Lease</u>. The provisions set forth in a written lease between the parties hereto with an Effective Date, as defined therein, of June 25, 2015 ("Lease"), are hereby incorporated by reference into this Memorandum.
- 2. <u>Demised Property</u>. Landlord has demised and let to Tenant the real property as more particularly described on **Exhibit A** attached hereto and made a part hereof ("Leased Premises").
- 3. <u>Term.</u> The initial term of the Lease shall begin on the Effective Date and shall continue for a period of twenty (20) years after the Rent Commencement Date (defined below). Tenant will have the right, at its election, to extend the term of the Lease for two (2) consecutive renewal terms of ten (10) years each (each an "Option Period") commencing on the day following the last day of the initial term or first Option Period, as applicable, and terminating ten (10) years thereafter, on the same terms and conditions set forth in the Lease.
- 4. Rent Commencement Date. The Rent Commencement Date, as defined in the Lease, is the date that is the earlier to occur of Tenant's substantial completion of the Improvements, as defined in the Lease, or one hundred fifty (150) days after the Effective Date.
- 5. <u>Purpose</u>. It is expressly understood and agreed by all parties that the sole purpose of this Memorandum of Lease is to give record notice of the Lease in order that third parties may have notice of the estate of Tenant in the Leased Premises and of the Lease, but in no way modifies the express and particular provisions of the Lease. All of the terms, conditions, provisions and covenants of the Lease are incorporated in this Memorandum by reference as though written out at length herein. In the event of any inconsistency between the provisions of this Memorandum and those of the Lease, the provisions of the Lease shall control.
