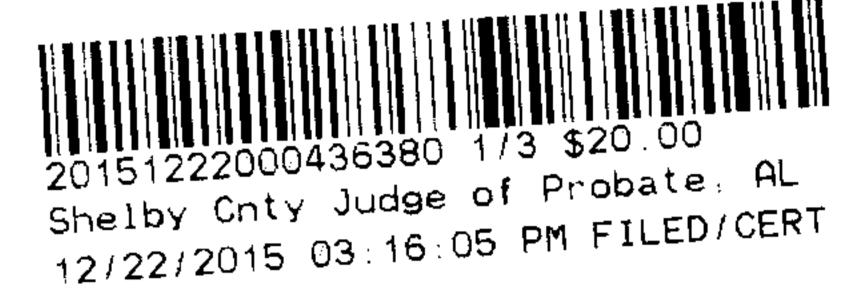

That in consideration of Ten Dollars and other valuable Consideration to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, I,
