KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 1st day of May, 2009, Ryan Willis and Veronica Willis, husband and wife, executed that certain mortgage on real property hereinafter described to Homeservices Lending, LLC Series A dba Mortgage South, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20090513000181070, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., successor by merger to Wells Fargo Home Mortgage, Inc., by instrument recorded in Instrument No. 20100426000126490, in the aforesaid Probate Office ("Transferee"); and

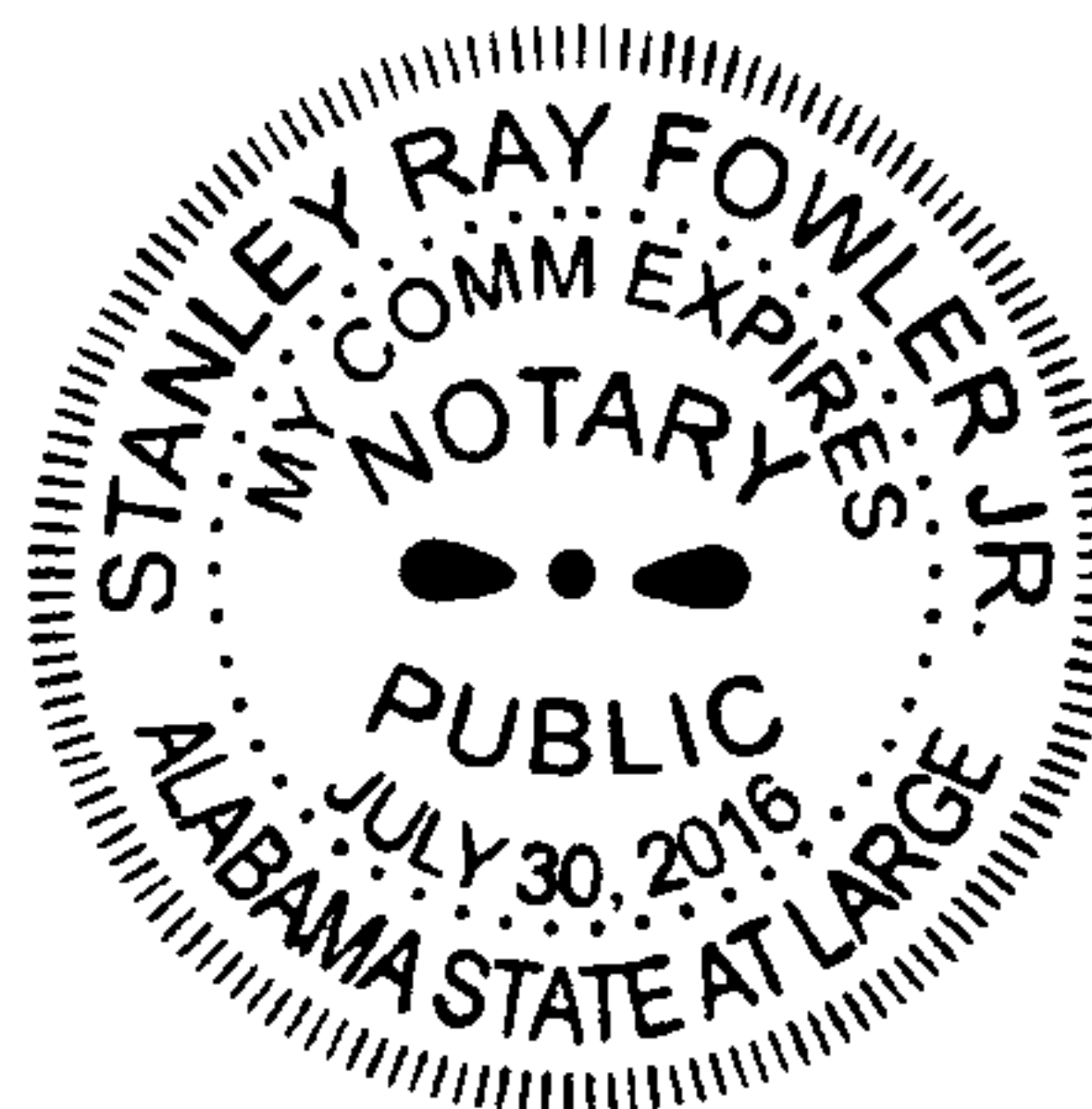
