County, Alabama, to-wit:



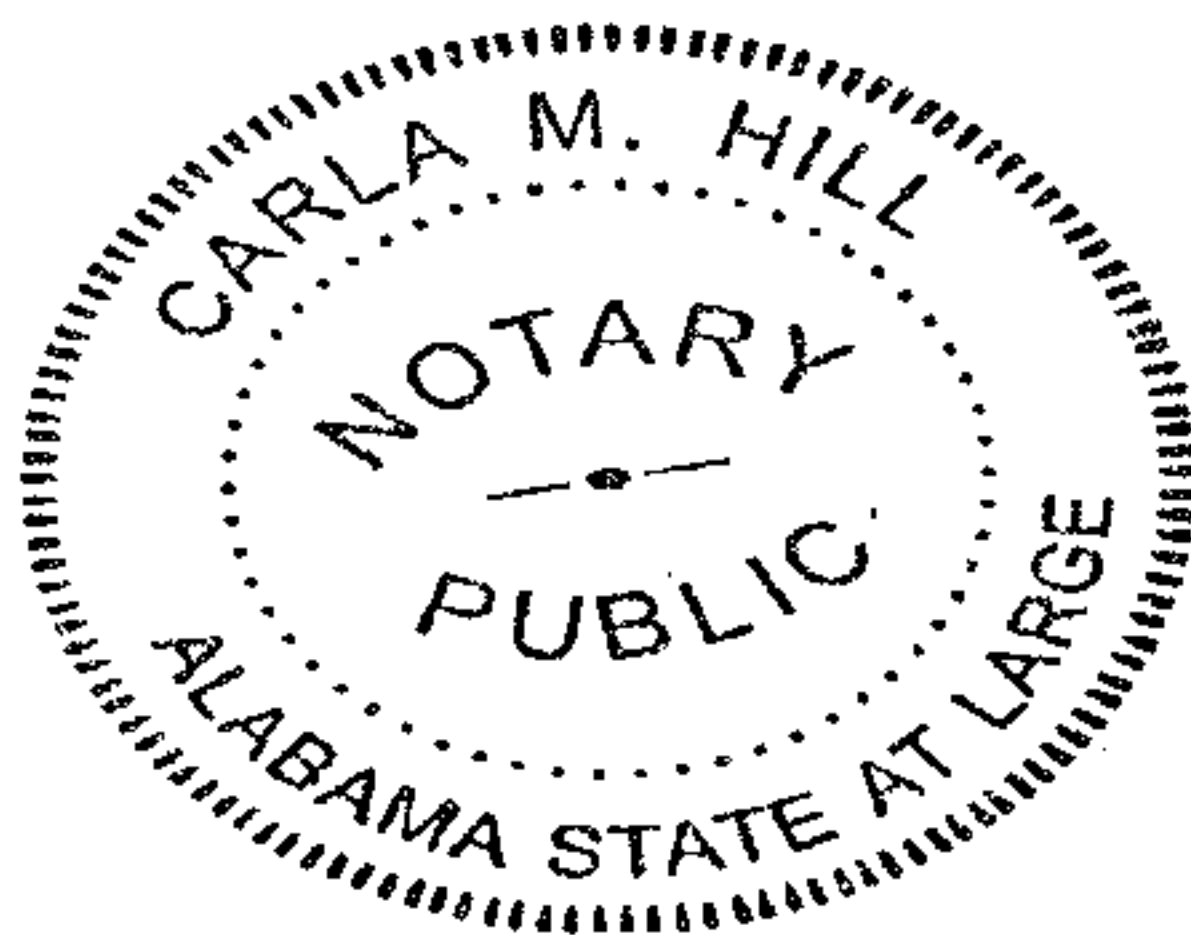
\$405,555.00 of the purchase price recited above has been paid from the proceeds of a
