Carden and Kay C. Carden, husband and wife**, Husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Michael Franks and Haley A. 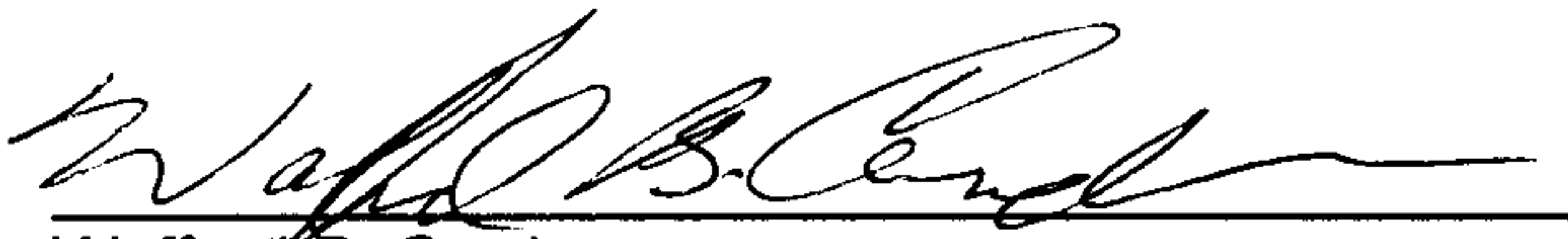

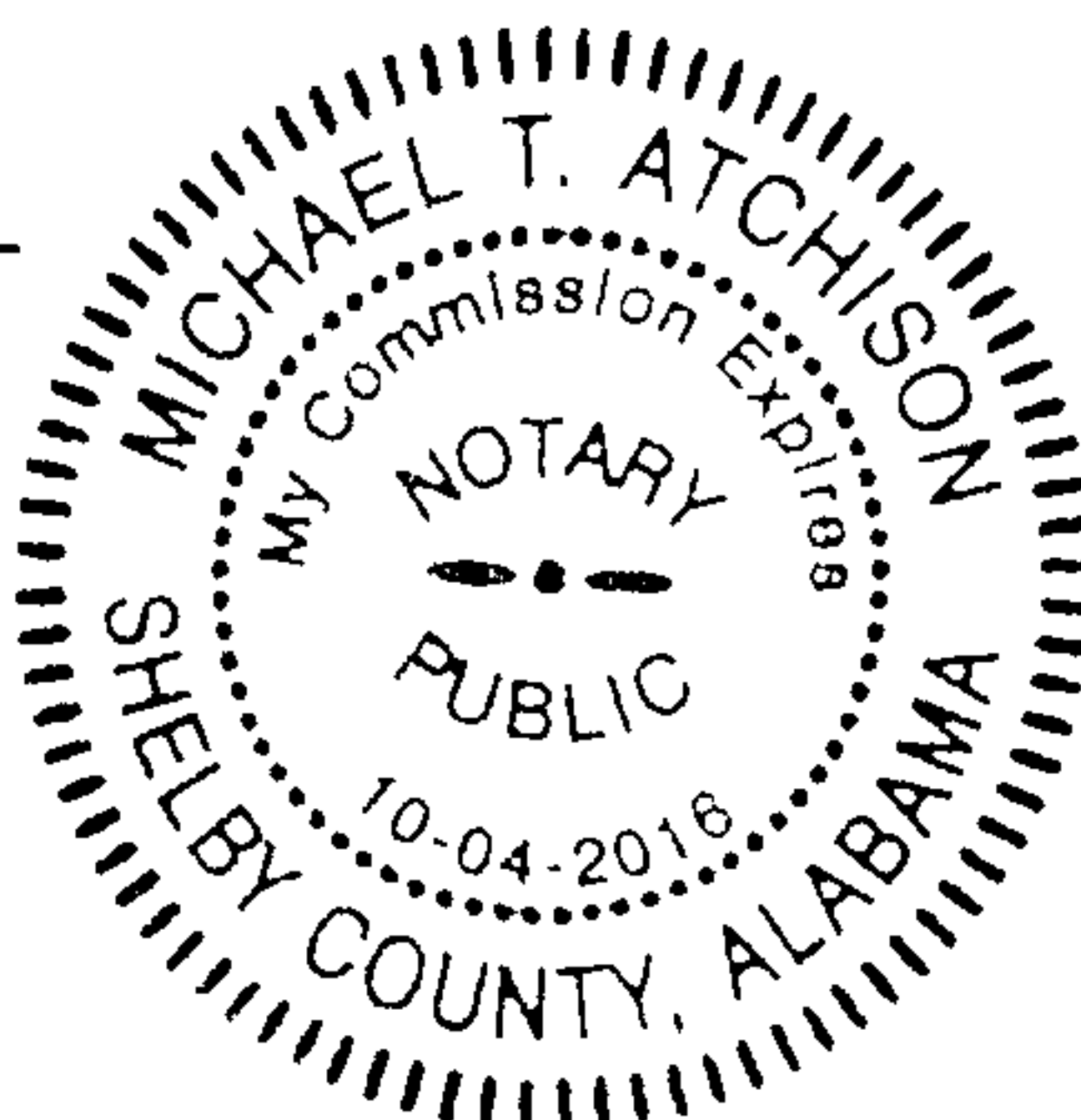
