(herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Mary Lou Smith and Darlene M. Young
(herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **SHELBY** County, Alabama, to-wit:

Lot 109, according to the Survey of Lacey's Grove Phase 2, as recorded in Map Book 38, page 19, in the Probate Office of Shelby County, Alabama.

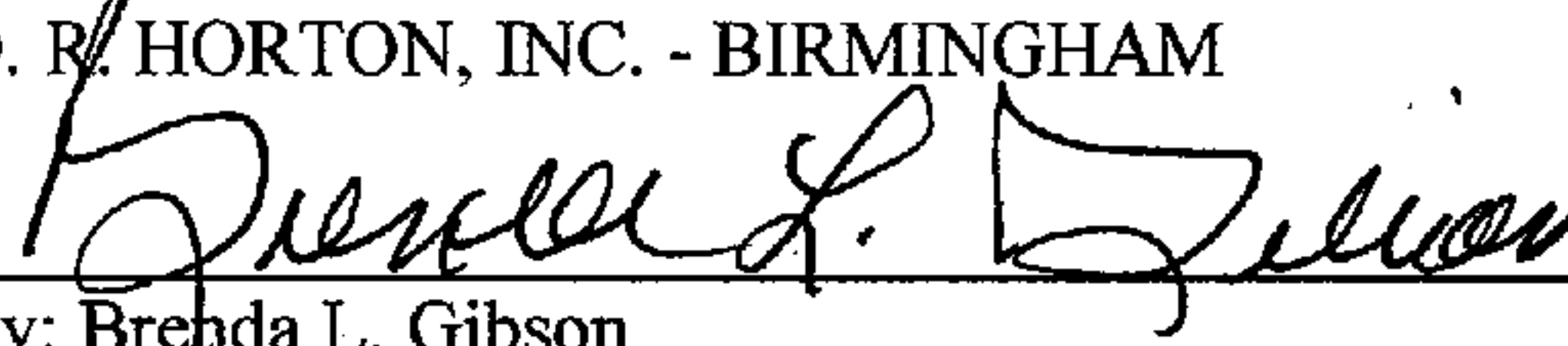

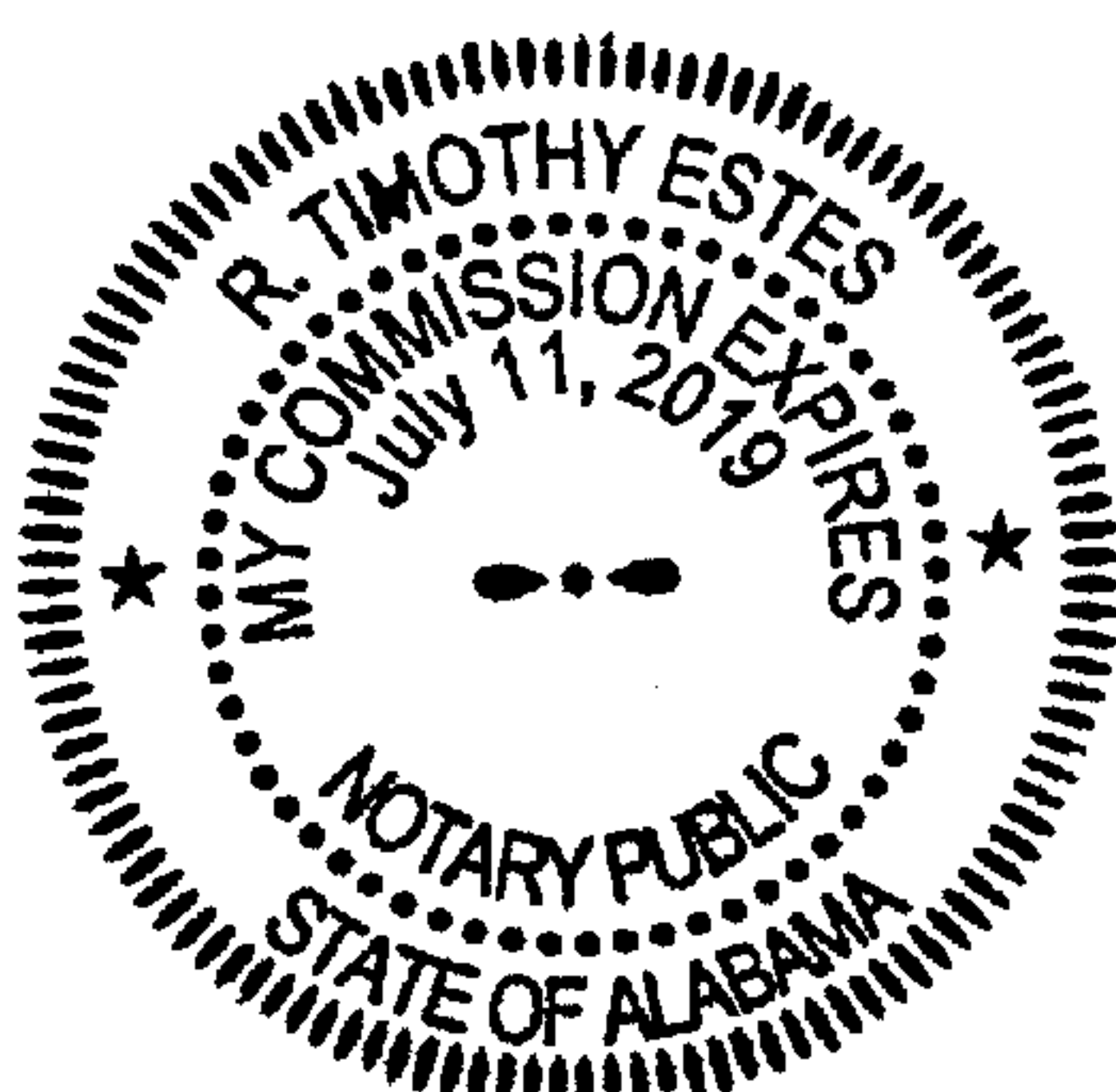

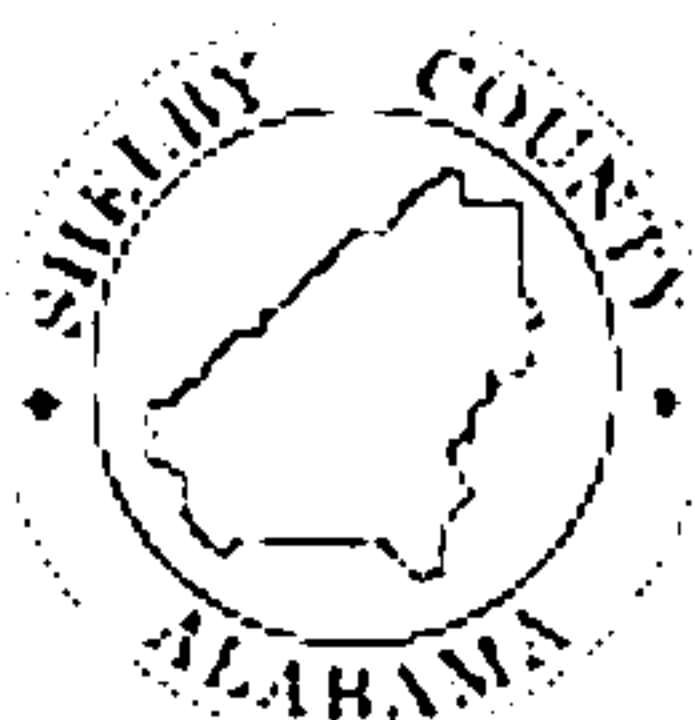
