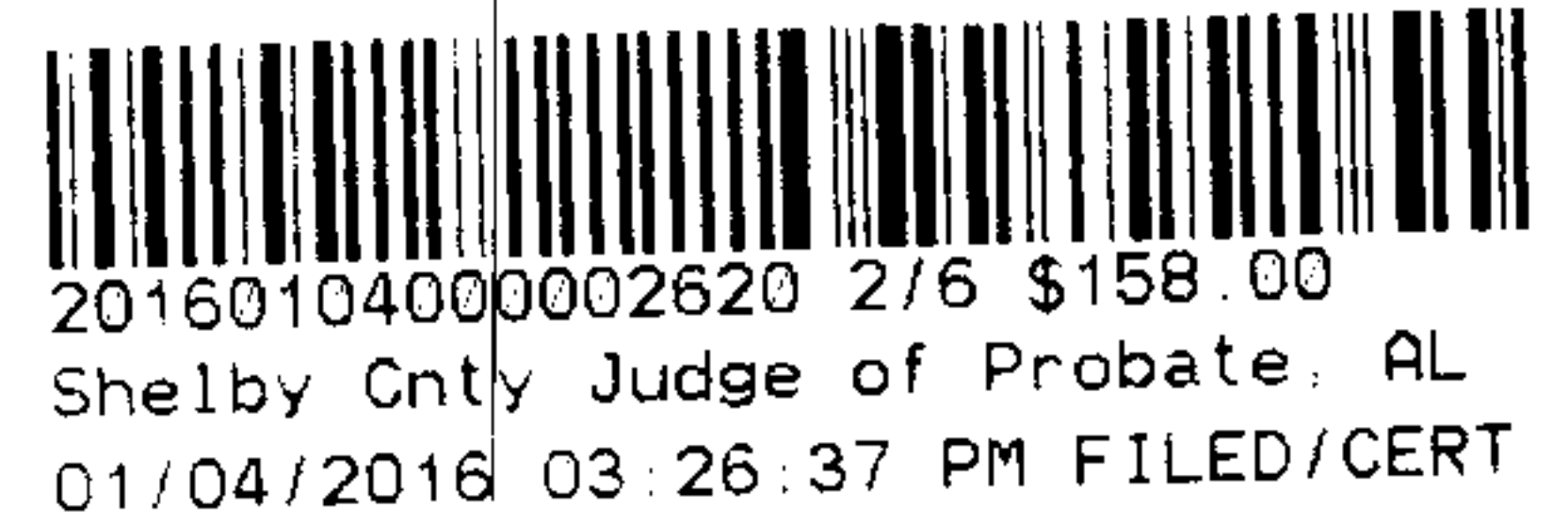

ARTICLE I

NAME

DIGITAL, L.L.C."***

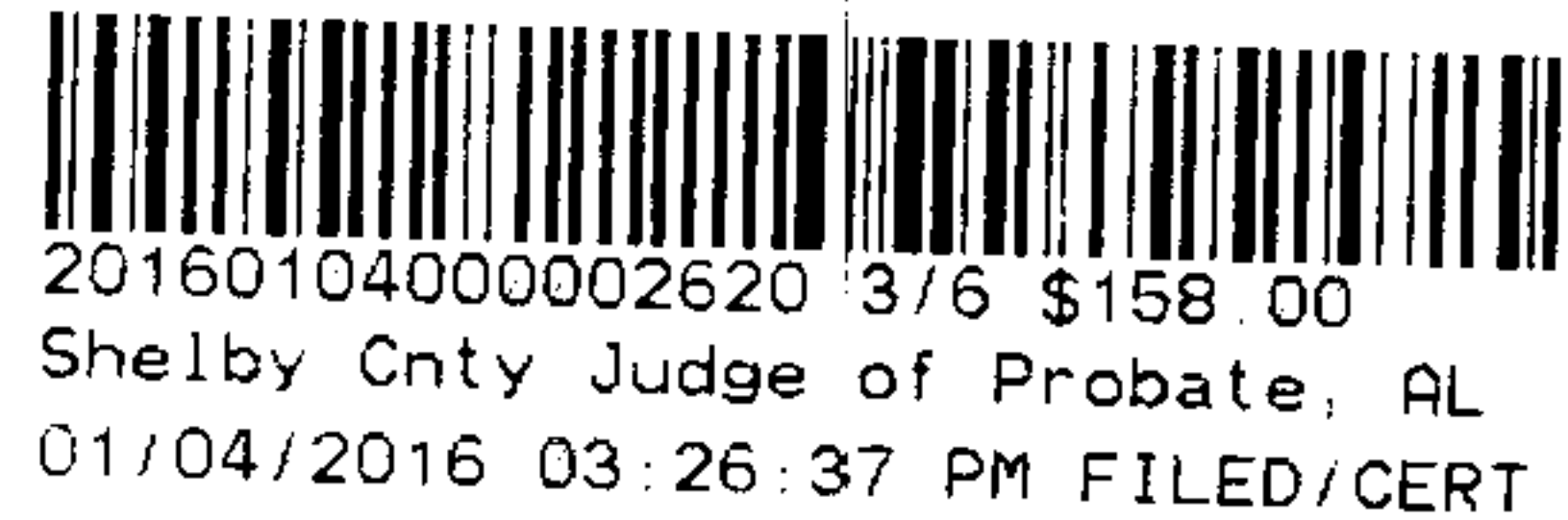
ARTICLE II

DURATION

ARTICLE IX

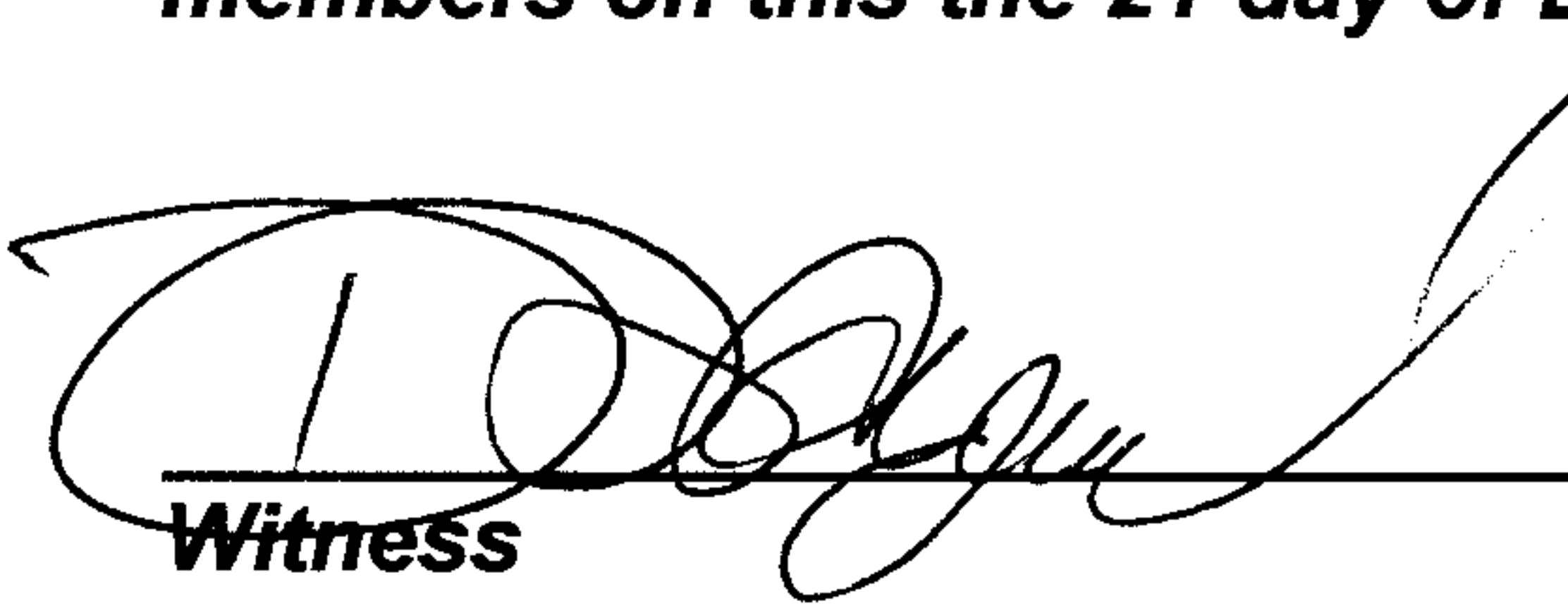
Any amendment to this Certificate of Formation shall require approval of all the members.

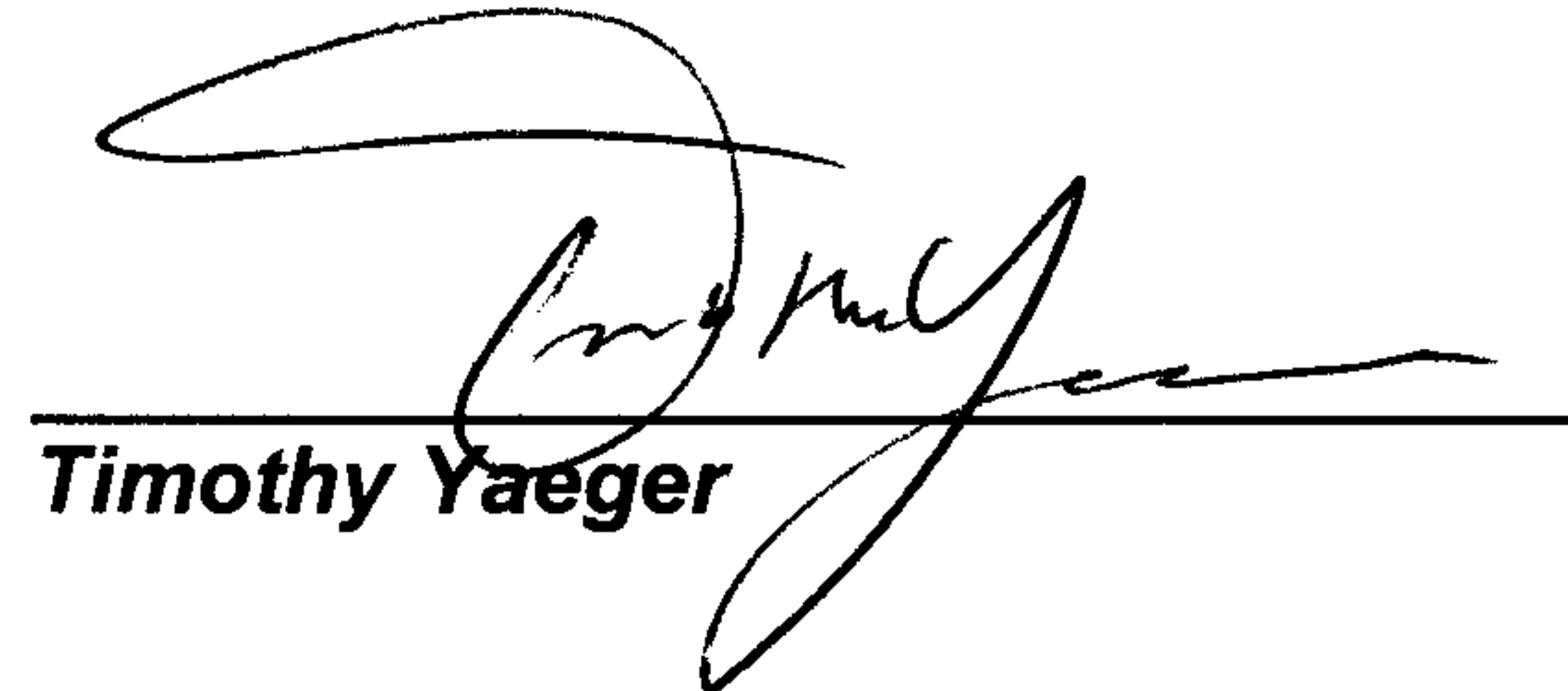

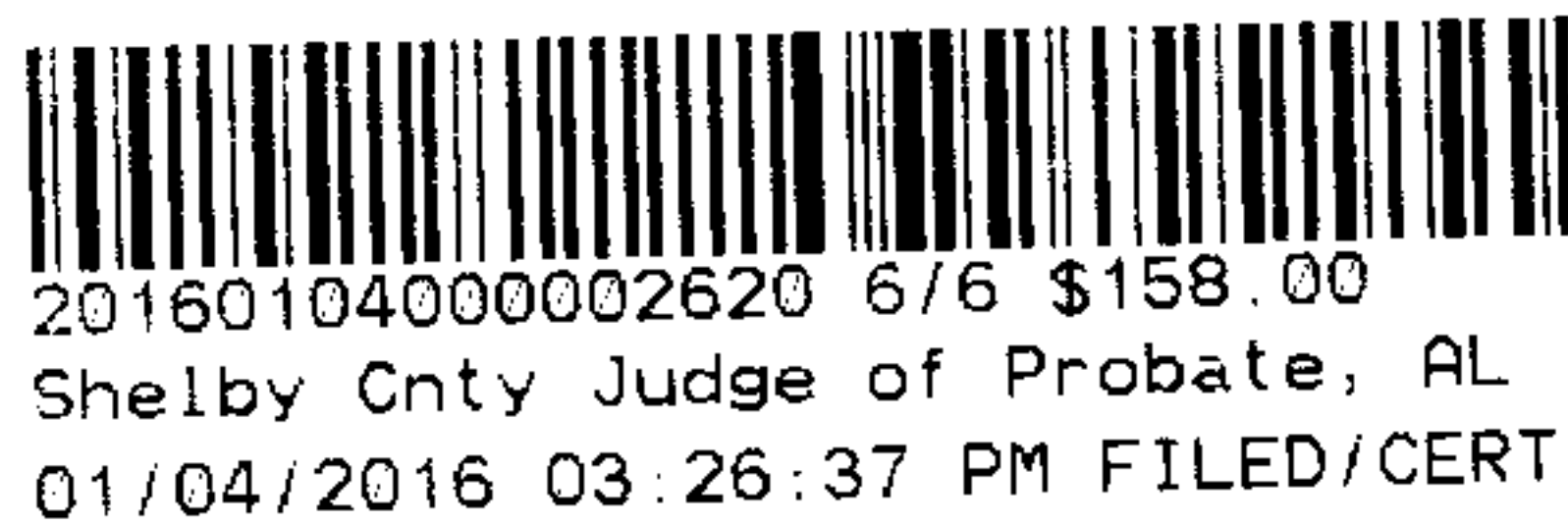
