THE UNDERSIGNED, for the purpose of merging Elite Custom Services, LLC, a New York limited liability company, with and into Elite Custom Services, LLC, an Alabama limited liability company, pursuant to the provisions of the New York Limited Liability Company Law and the Alabama Business and Nonprofit Entity Code, as the same now exists or as may hereafter be amended (the "Law"), does hereby adopt the following Certificate of Merger:

ARTICLE I.

Elite Custom Services, LLC, a New York limited liability company with New York DOS ID# 3820411 and qualified to do business in Alabama with Secretary of State Entity ID# 345-059, ("ECS New York") shall merge with and into Elite Custom Services, LLC, an Alabama limited liability company ("ECS Alabama").

ARTICLE II.

The merger shall be effective upon the filing in the Office of the Secretary of State of Alabama of this Certificate of Merger.

ARTICLE III.

ECS New York was formed in Yates County, New York by filing Articles of Organization with the Judge of Probate of Yates County, New York on June 10, 2009. ECS Alabama was formed in Shelby County, Alabama by filing a Certificate of Formation with the Judge of Probate of Shelby County, Alabama on November 19, 2015.

ARTICLE IV.

A Plan of Merger has been approved and executed by each of the constituent entities to the merger.

ARTICLE V.

The name of the surviving entity is "Elite Custom Services, LLC," an Alabama limited liability company.

Upon the merger, no constituent business entity domiciled in New York shall exist.

ARTICLE VIII.

ARTICLE X.


The Plan of Merger is on file with ECS Alabama at its offices at 81 Silver Loop, Columbiana, Alabama 35051.

A copy of the Plan of Merger will be furnished by ECS Alabama, on request and without cost, to any owner of any entity which is a party to the merger.


