


ARTICLES OF ORGANIZATION

OF

COLUMBIANA STATION, LLC



Pursuant to the Provisions of the Code of Alabama, Title 10A, Chapter 5, Article 1.01, *et seq.*, the undersigned hereby adopts the following limited liability company Articles of Organization:

ARTICLE I

The name of the limited liability company is: Columbiana Station, LLC (hereinafter referred to as the "Company").

ARTICLE II

The period of duration for the Company is perpetual, beginning from the date these Articles of Organization are filed in the Office of the Judge of Probate of the county in which the initial registered office of the Company is located.

ARTICLE III

The purpose or purposes for which the Company is organized is the transaction of any and all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act, including, but not limited to, any and all transactions which are necessary, appropriate or incidental to the operation and rental of an office and warehouse building.

ARTICLE IV

The location and street address of the initial registered office of the Company is 455 Highway 70, Columbiana, Alabama 35051, and the name of its initial registered agent at such address is Kevin Noel Ricke.

ARTICLE V

The name and addresses of the Company's initial members are:

ARTICLE VI

The Company shall be managed by its members as provided in the Operating Agreement of the Company.

ARTICLE VII

The initial members of the Company shall have no right to admit additional members, except in accordance with the Operating Agreement of the Company, as amended from time to time.


ARTICLE VIII



ARTICLE IX

All other provisions for the regulation of the internal affairs of the Company shall be set out in the Operating Agreement of the Company, as amended from time to time, and shall be in compliance with the Alabama Limited Liability Company Act.


