TO THE HONORABLE JUDGE OF PROBATE  
SHELBY COUNTY, ALABAMA:

Pursuant to the provisions of the Alabama Limited Liability Company Law of 2014, Alabama Code §10A-5A-1.01 et seq. (the “Law”), the undersigned limited liability company hereby files this certificate of amendment (the “Certificate of Amendment”) as follows:

**FIRST:** The name of the limited liability company is Daniel Ross Bridge, LLC (the “Company”).

**SECOND:** The Articles of Organization of the Company (as amended, the “Articles”) were filed on February 20, 2003, in the office of the Judge of Probate of Shelby County, Alabama.

**THIRD:** The Articles were amended by that certain First Amendment to Articles of Organization filed on July 10, 2003, in the office of the Judge of Probate of Shelby County, Alabama.

**FOURTH:** The Articles are hereby amended as follows:

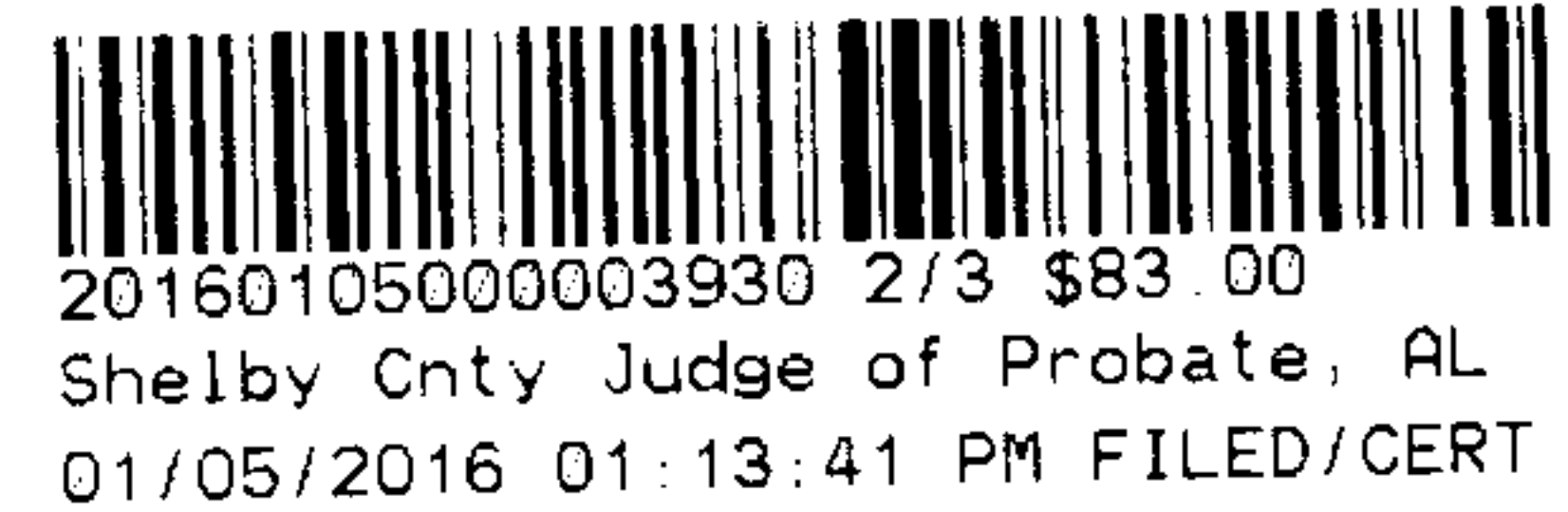
(a) Subsection (c) of Article 2 is hereby amended by deleting the reference to “Alabama Limited Liability Company Act, as amended” and replacing it with “Alabama Limited Liability Company Law of 2014, Alabama Code §10A-5A-1.01 et seq. (the “Law”).”

(b) Article 4 is hereby amended in its entirety to read as follows: “4. **Duration.** The period of the Company’s duration shall be perpetual, provided that the Company shall be dissolved and its affairs shall be wound up upon the occurrence of any event of dissolution specified in Section 10A-5A-7.01 of the Law.”

(c) Article 5 is hereby amended in its entirety to read as follows: “5. **Registered Office and Agent.** The location and mailing address of the registered office of the Company shall be 3660 Grandview Parkway, Suite 100, Birmingham, Alabama 35243, and the name of the registered agent at said address shall be Daniel Communities, LLC.”

(d) Article 6 is hereby amended in its entirety to read as follows: “6. **Member.** There is at least one member of the Company. The name and mailing address of the member of the Company are:

(e) Article 9 of the Articles is hereby amended by deleting the last sentence of such Article and replacing it with the following: “The name and address of the manager of the Company, who shall serve as manager of the Company until its successor is elected, are:

Daniel Communities Management Corp.  
3660 Grandview Parkway  
Suite 100  
Birmingham, Alabama 35243”

(f) A new Article 10 is hereby added to the Articles to read in its entirety as follows: “The Company elects to be governed by, and shall be governed by, the Law, as it may be amended from time to time.”


**FIFTH:** The foregoing amendment to the Articles was approved in the manner required by the Law and the governing documents of the Company.
