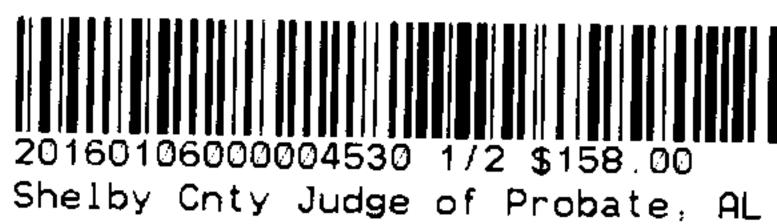

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Three Hundred Forty-Nine Thousand Nine Hundred and 00/100 (\$349,900.00), and other good and valuable consideration, this day in hand paid to the undersigned Ridge Crest Homes, LLC, an Alabama limited liability company (hereinafter referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, Ricky Collings and Victoria Collings, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 1-133, according to the Map and Survey of Chelsea Park, First Sector, Phase IV, as recorded in Map Book 36, Page 24, in the Office of the Judge of Probate of Shelby County, Alabama.

Together with the nonexclusive easement to use the Common Areas as more particularly described in Declaration of Easements and Master Protective Covenants of Chelsea Park, a Residential Subdivision, executed by the Grantor and filed for record as Instrument No. 20041014000566950 in the Probate Office of Shelby County, Alabama and Declaration of Covenants, Conditions, and Restrictions for Chelsea Park First Sector, Phase 3 & 4, executed by Grantor and Chelsea Park Residential Association, Inc. and recorded as Instrument No. 20060605000263850, (which, together with all amendments thereto, are hereinafter collectively referred to as the "Declaration").

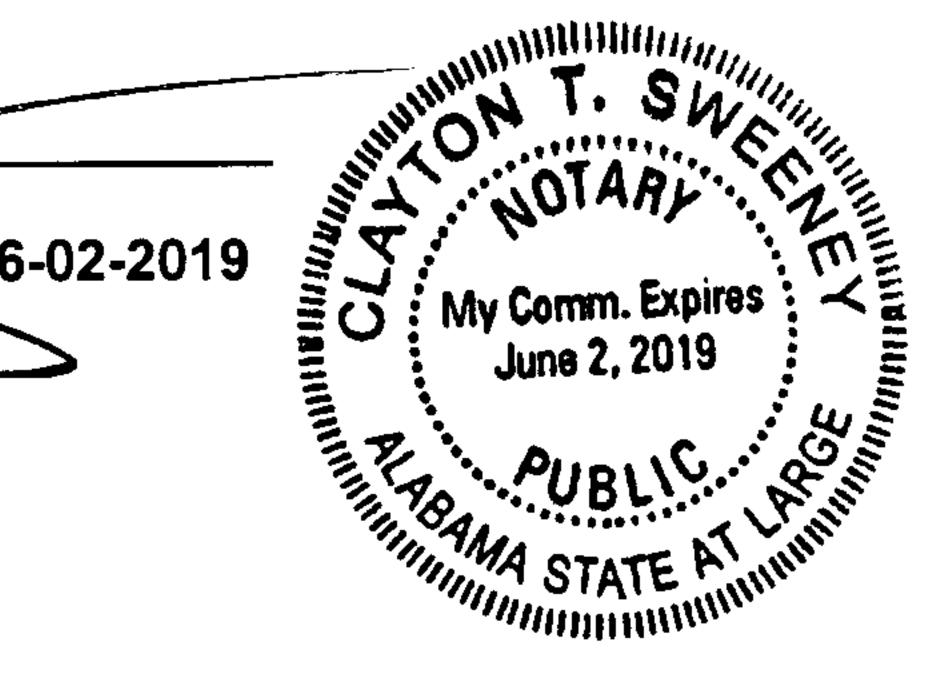
