(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:



Lot 45, according to the Southern Pines 6th Sector, as recorded in Map Book 9, Page 107, in the Probate Office of Shelby County, Alabama.



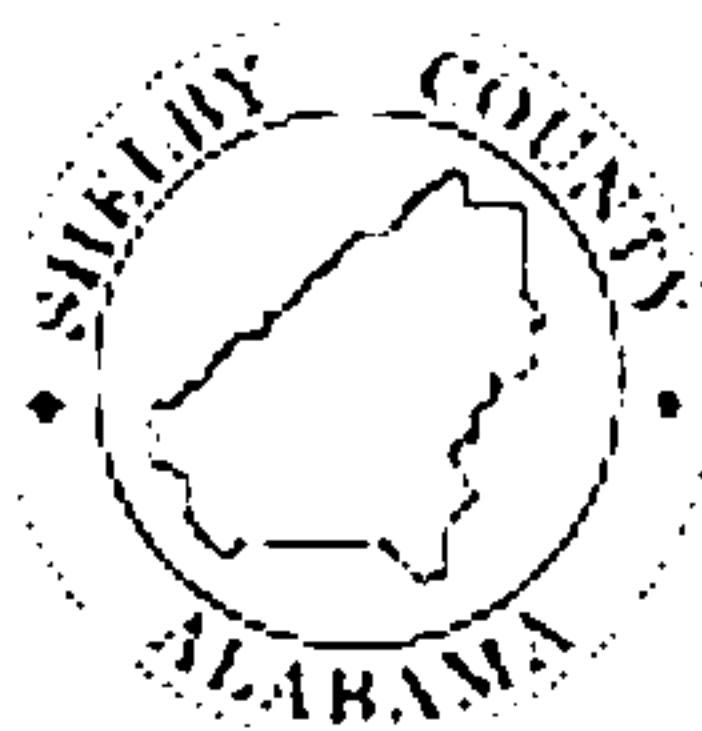
