That in consideration of Three Thousand Four Hundred Fifty and no/100 DOLLARS (\$3,450.00) to the undersigned GRANTOR in hand paid by the GRANTEE herein, the receipt whereof is acknowledged, the undersigned Donna L. Larimer, formerly known as Donna L. Wallace, unmarried (herein referred to as GRANTOR) does grant, bargain, sell and convey unto Mark A. Fowler and Lonnie C. Long, in equal shares as tenants in common (herein referred to as GRANTEE) the following described real estate situated in Shelby County, Alabama to-wit:

A tract of land located in the SW 1/4 of the SW 1/4 and the NW 1/4 of the SW 1/4 of Section 8, Township 24 North, Range 13 East, Shelby County, Alabama, described as follows: Commence at the Southwest corner of Section 8. Subject to easements, covenants, conditions, rights of way, and covenants of record.

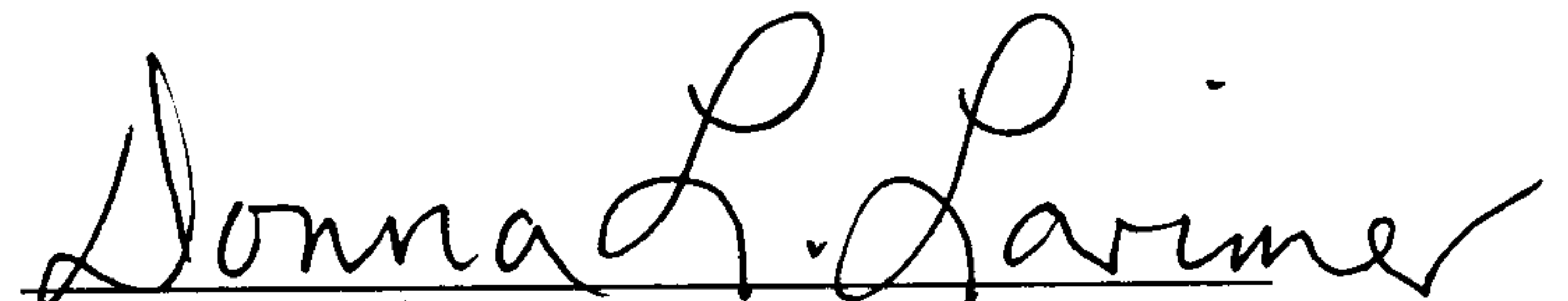
TO HAVE AND TO HOLD to the said GRANTEE, his, her or their heirs and assigns forever.

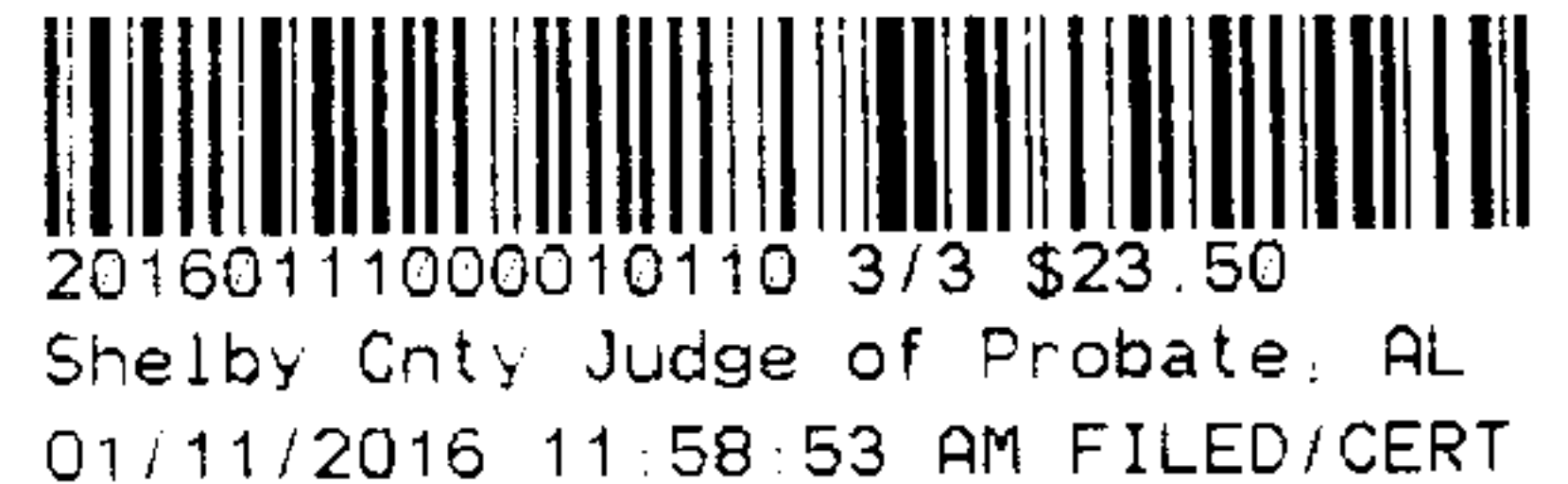
