KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 25th day of January, 2006, Floyd E. Warren, a married man and wife, Wordine H. Warren, joined by Jasmon L. 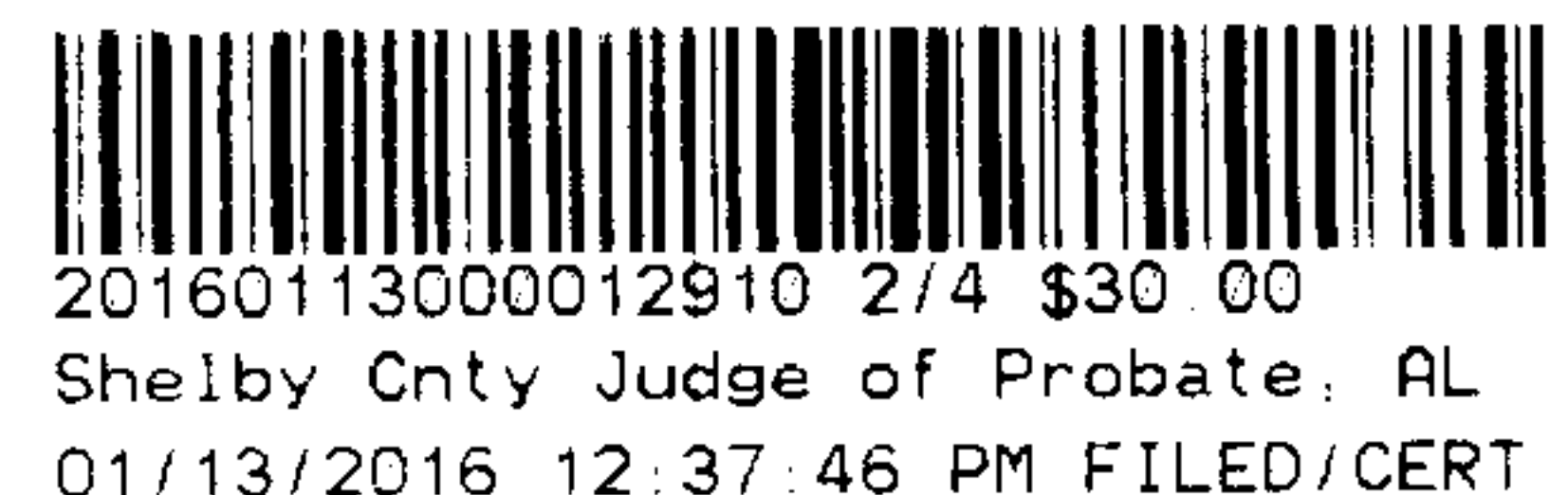

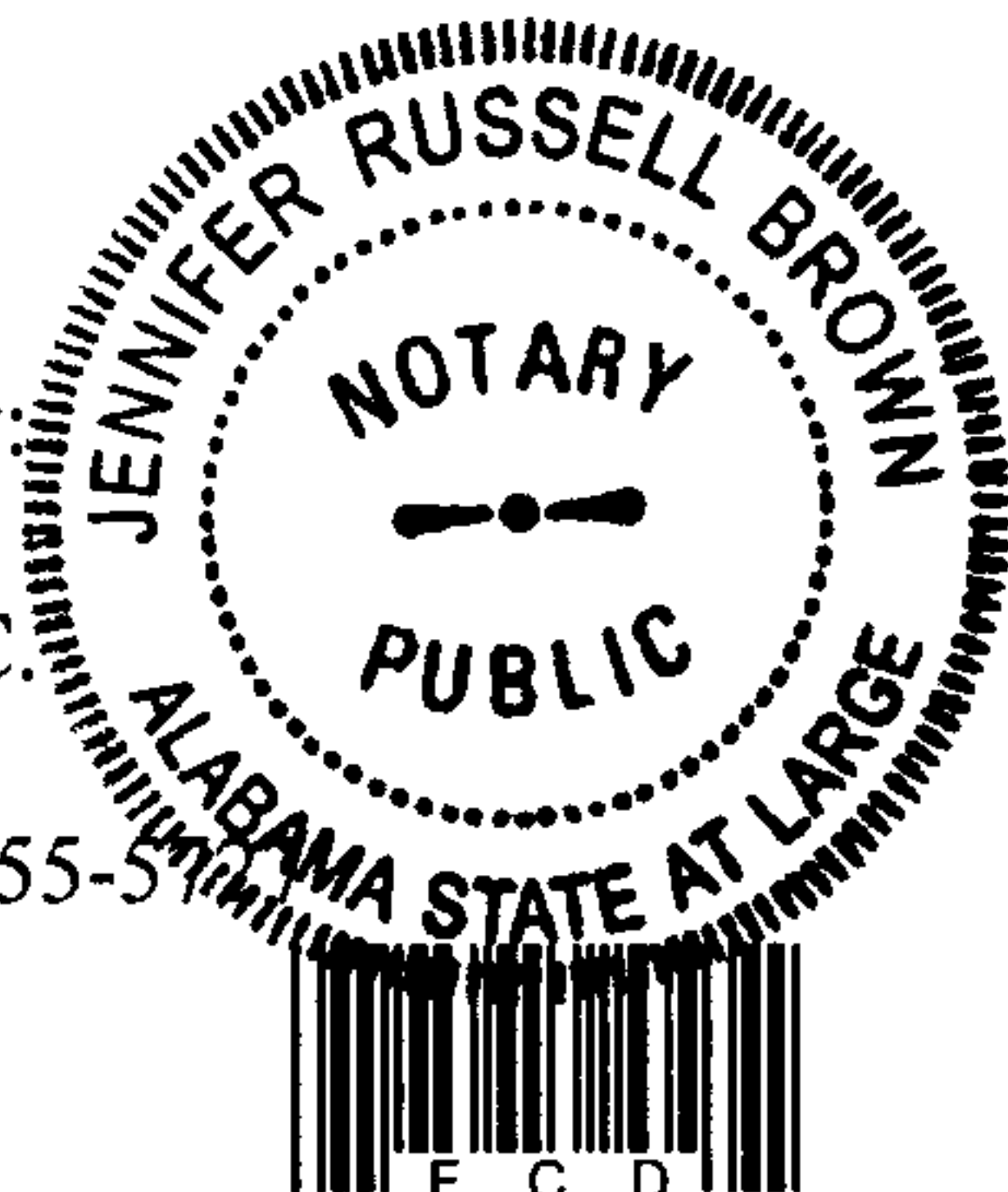
