Lobell, Ethel B. Lobell and Amy Lobell Clement**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby , State of Alabama, to-wit:

Lot 23, according to the Survey of Parkside, a residential Townhouse Development, as recorded in Map Book 22 Page 133 in the Probate Office of Shelby County, Alabama.

Subject to existing easements, current taxes, restrictions and covenants, set-back lines, rights of way and mortgages, if any, of record.


\$94,400.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

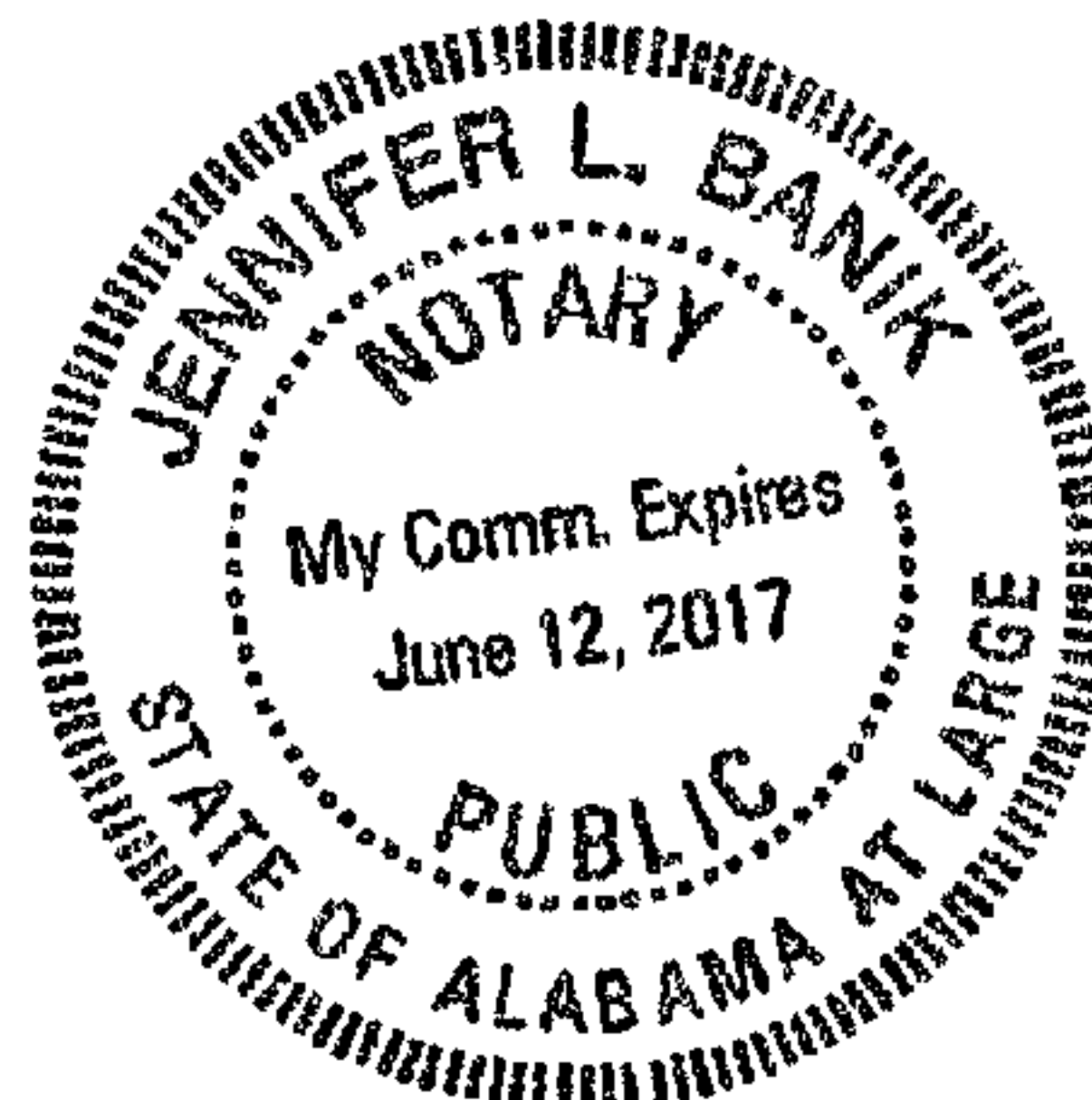
