That in consideration of the sum of **Two Hundred Fifty One Thousand Six Hundred Dollars and No Cents (\$251,600.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Mary Sue Madaris, as Successor Trustee of J. Paul Johnson Trust, dated September 19, 2007**, (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Terry Knight and Catrina Y. Knight**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

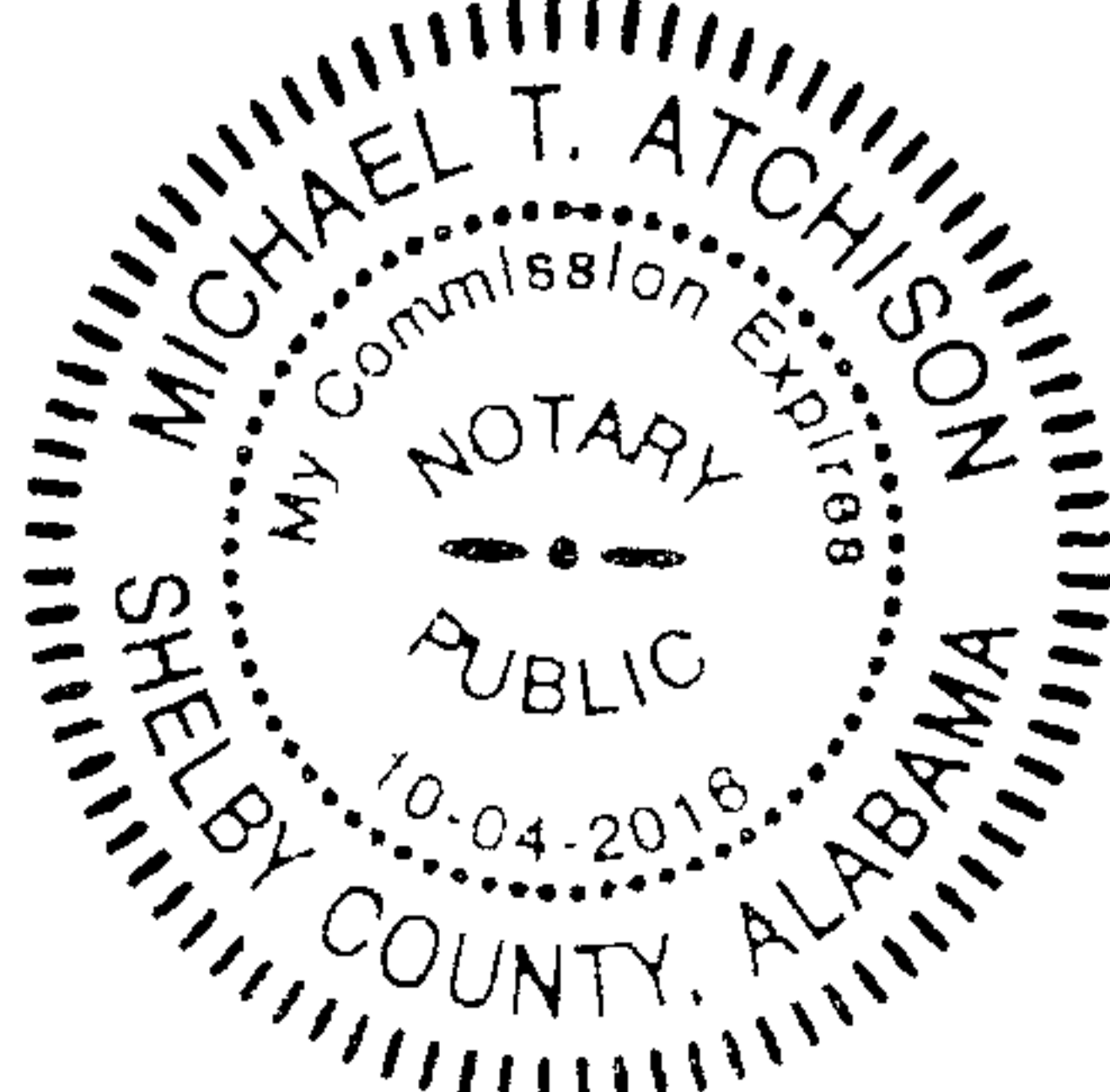

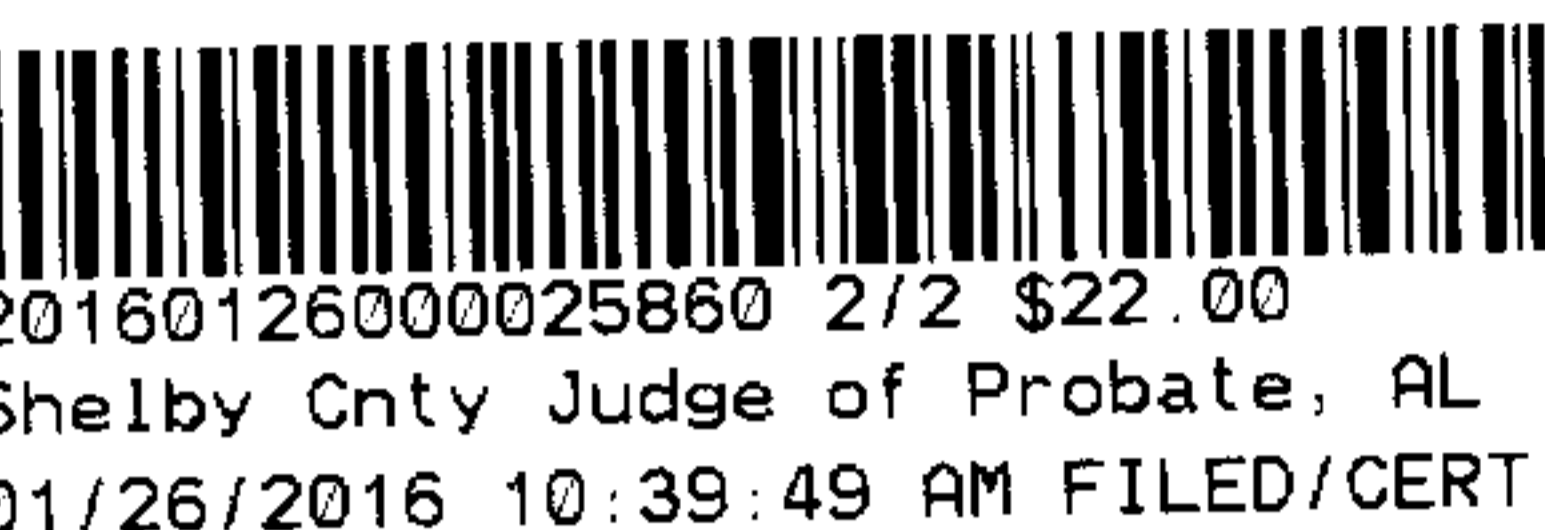
