No part of the homestead of the grantor herein or his spouse.

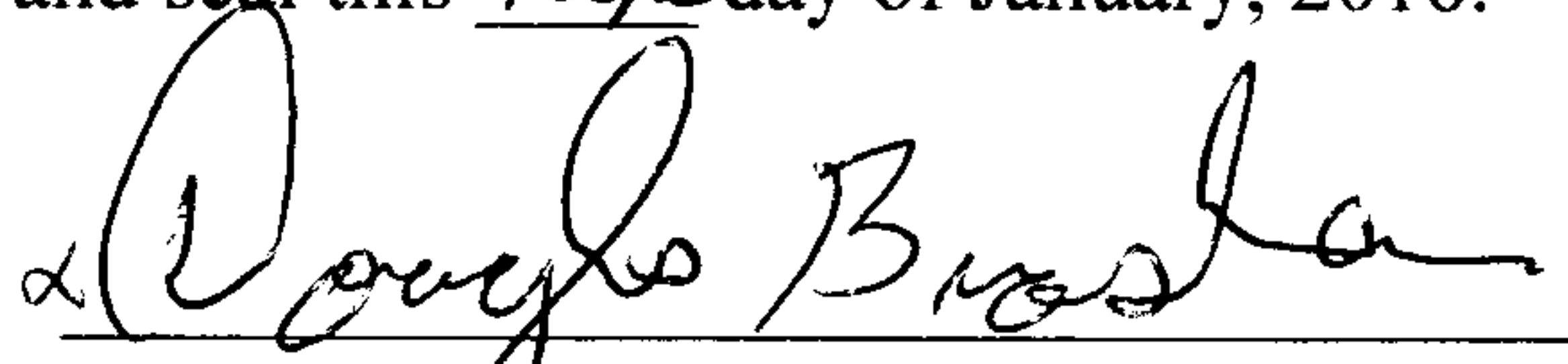
SUBJECT TO:

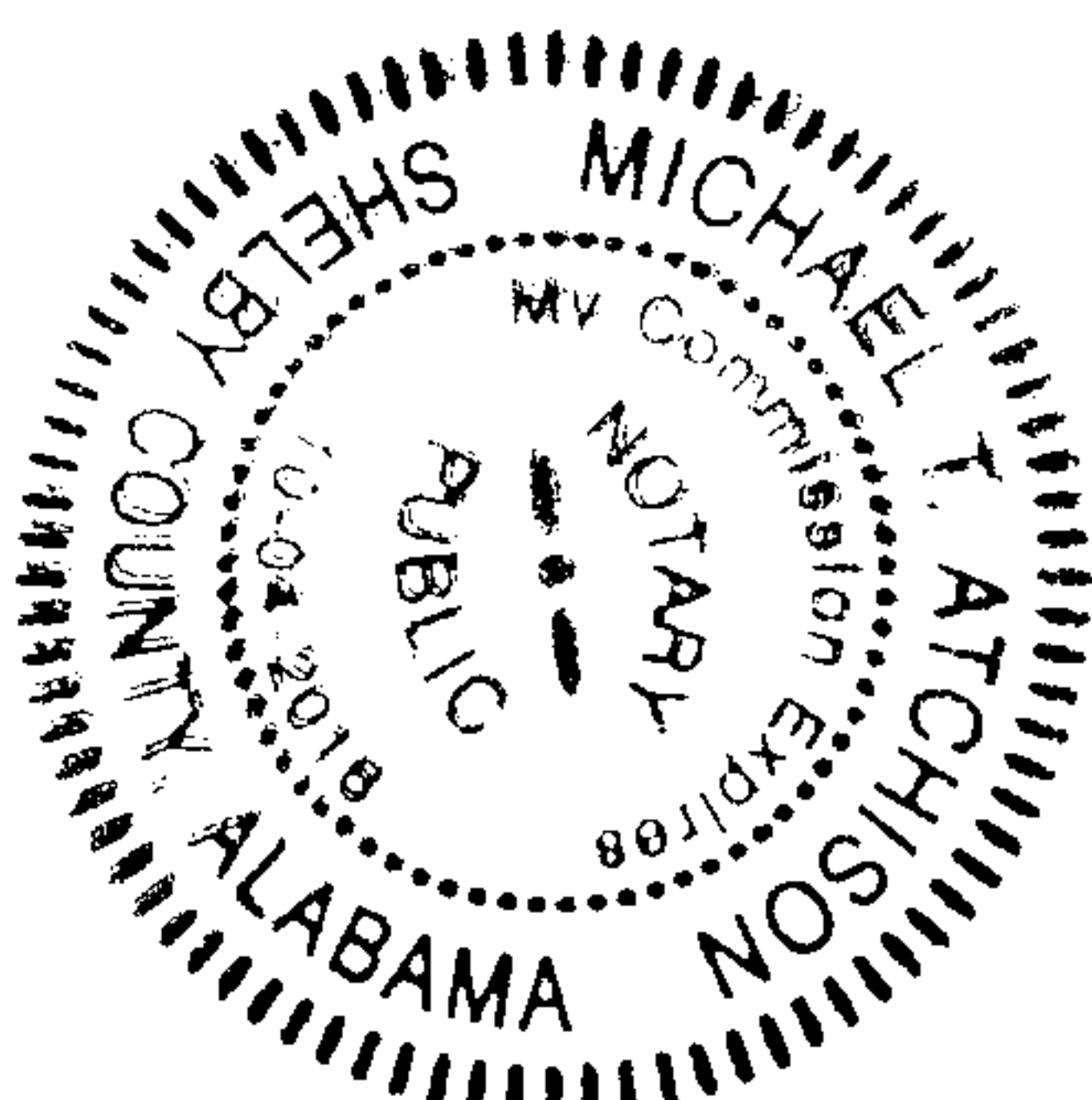

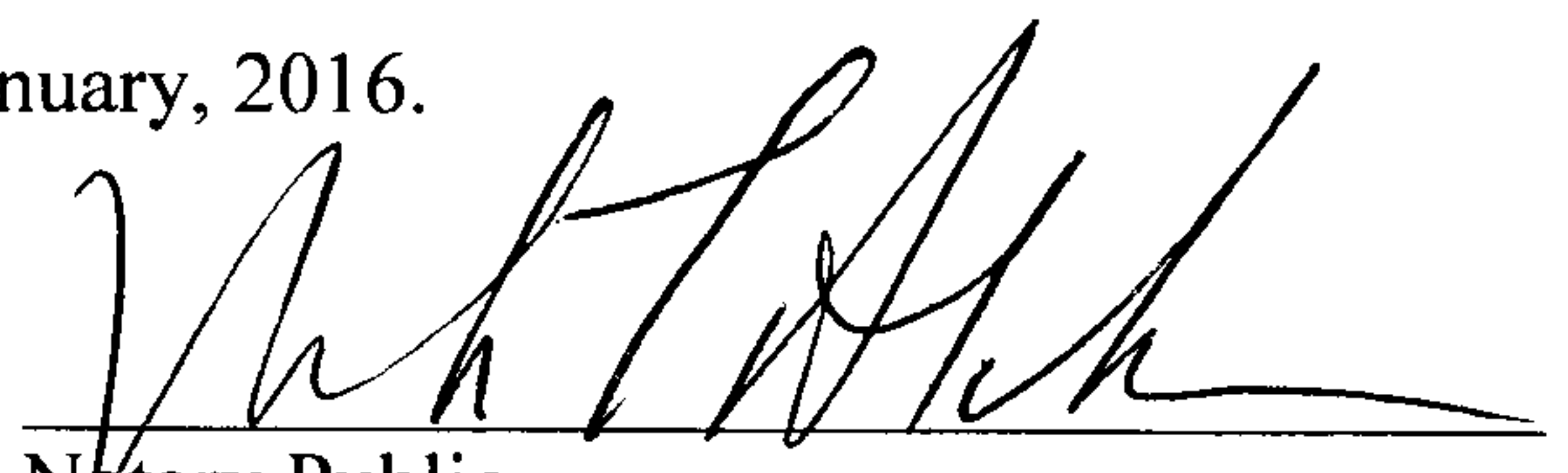
