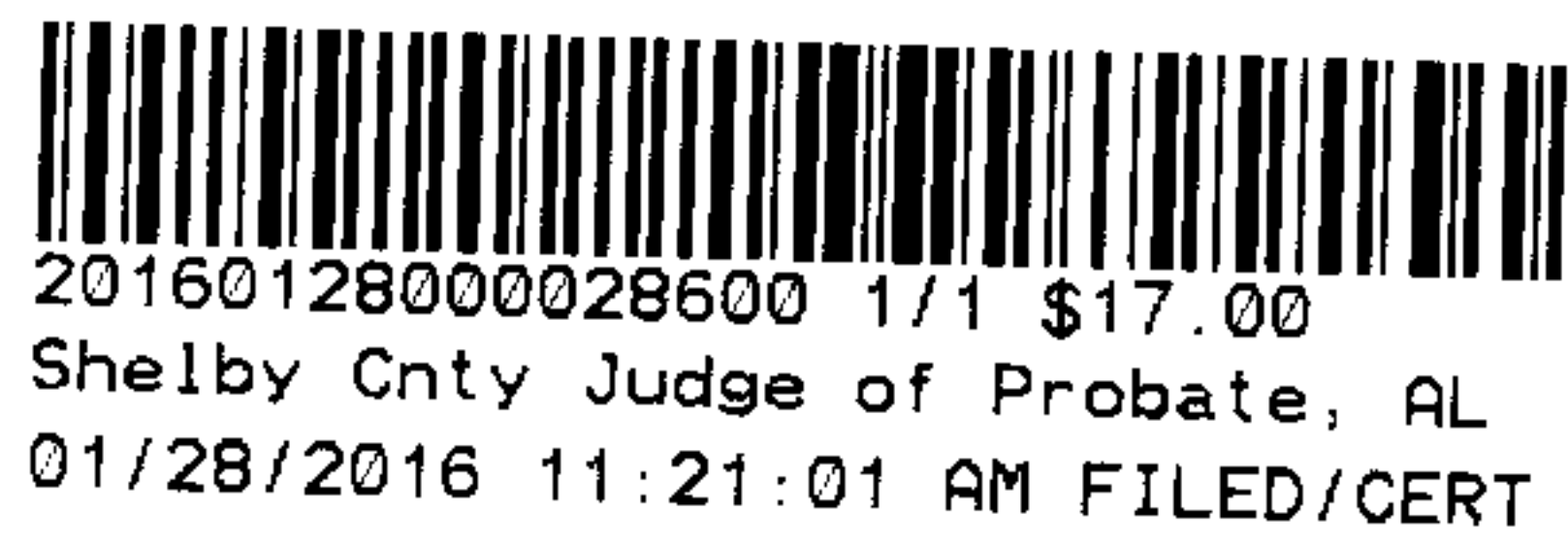

PARTIAL RELEASE OF LIEN
