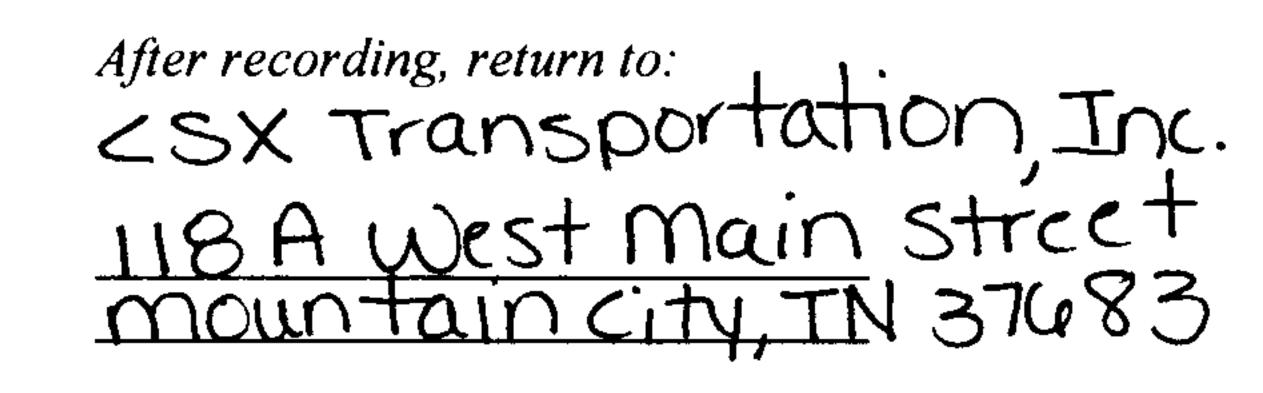

### PARCEL 4:

A parcel of land situated in the Southeast one-quarter of the Northeast one-quarter of Section 15, Township 20 South, Range 3 West, Shelby County, Alabama, being particularly described as follows:
