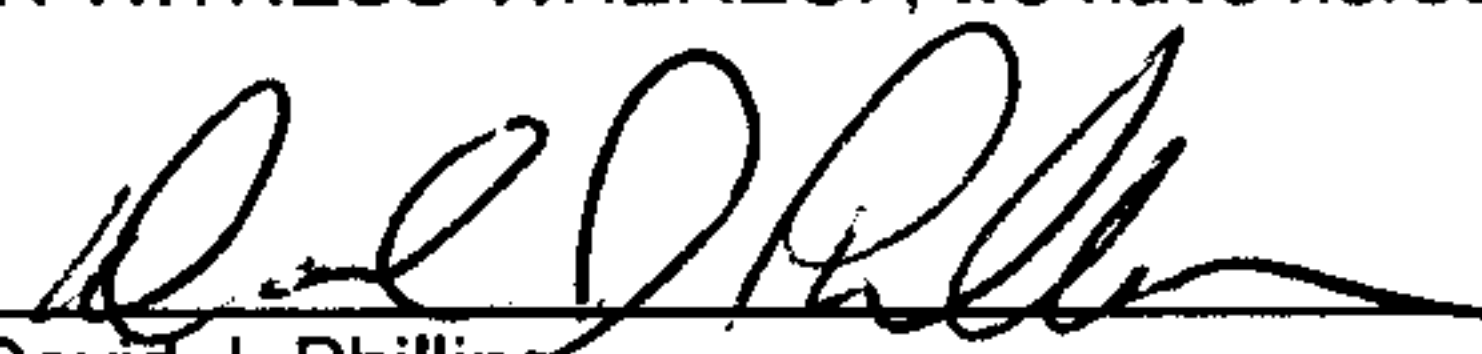

Subject to easements, reservations and restrictions at record.

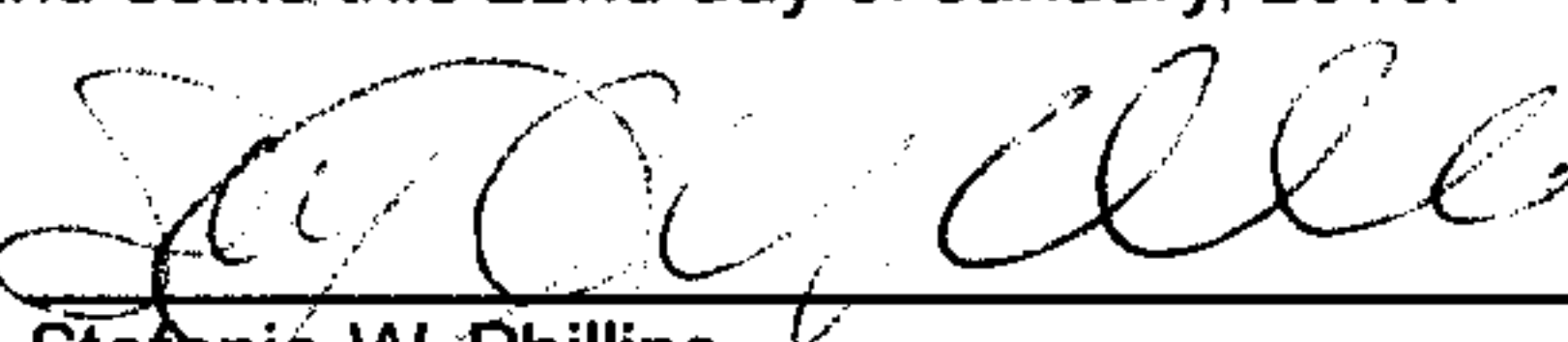
