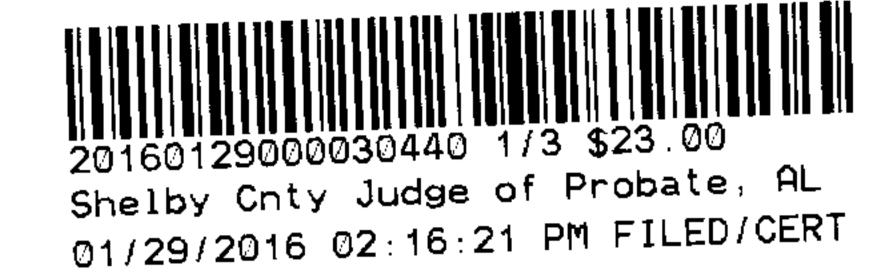
MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS: That Terry Partridge, Jr., a married man did, on to-wit, November 8, 2013, execute a mortgage to Mortgage Electronic Registration Systems, Inc. as nominee for HomeTown Mortgage Services, Inc., which mortgage is recorded in Instrument Number 20131112000443340 on November 12, 2013, in the Office of the Judge of Probate of Shelby County, Alabama, and secured indebtedness having been transferred to JPMorgan Chase Bank, National Association at Instrument Number 20150212000015680.
