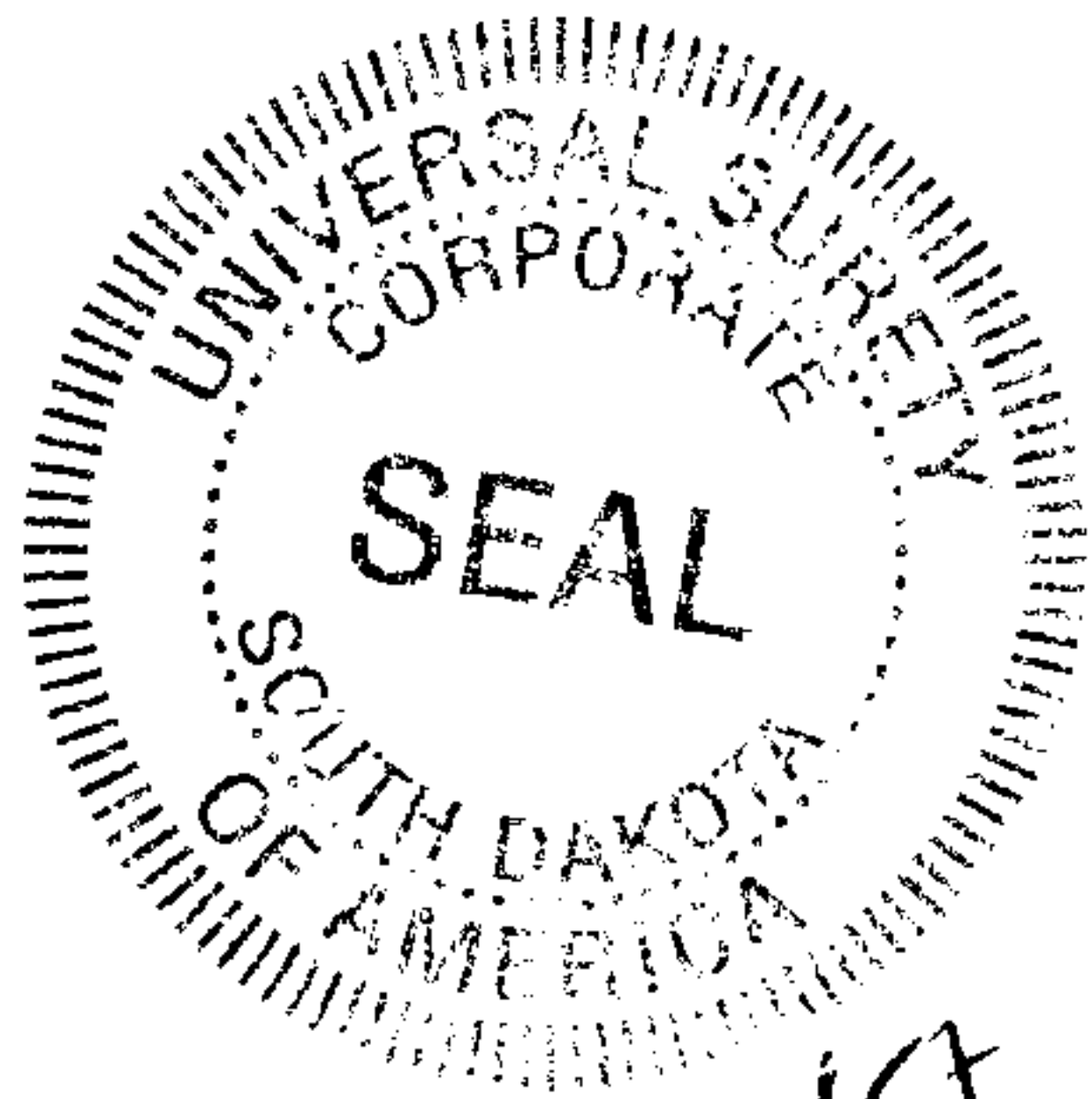

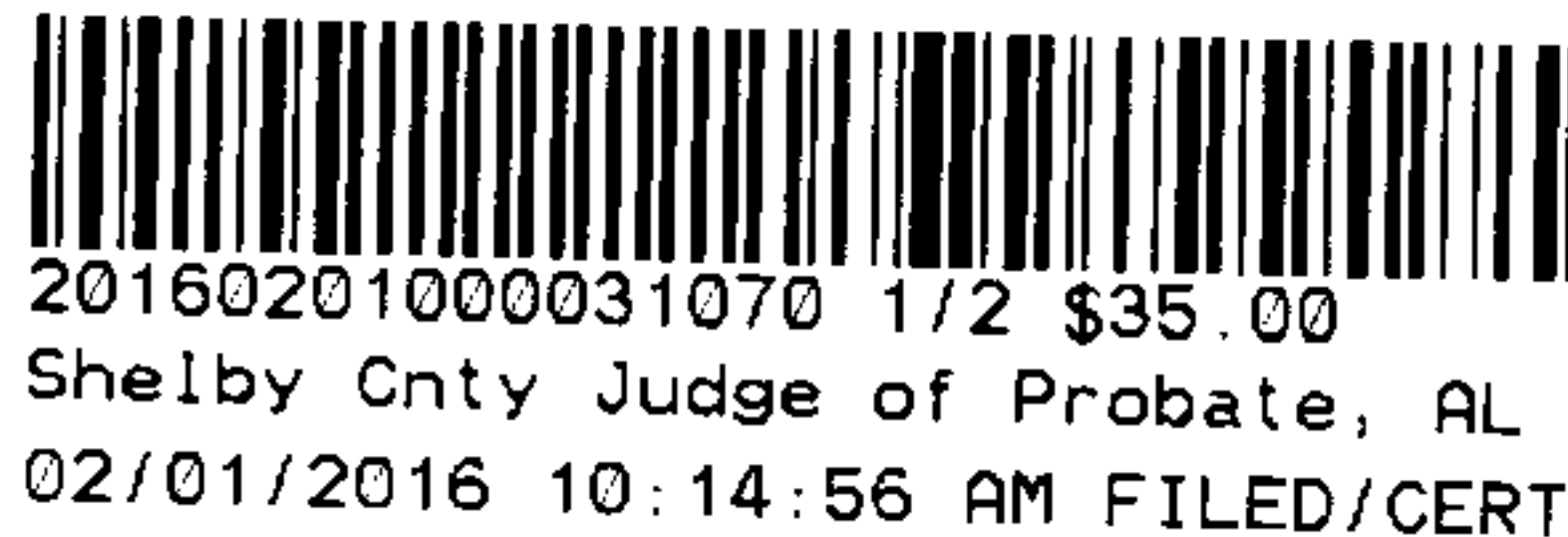

### OATH OF OFFICE

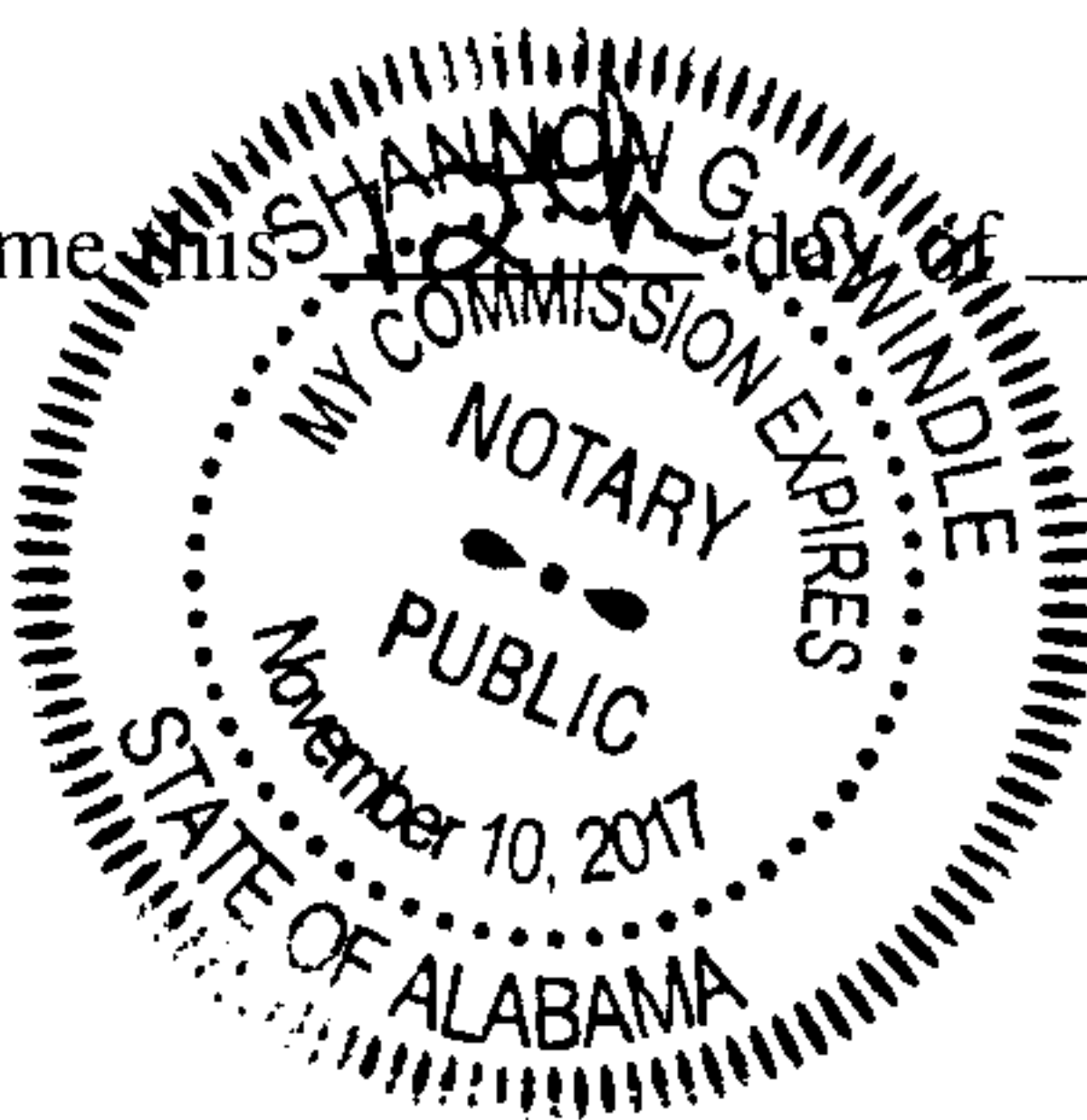
