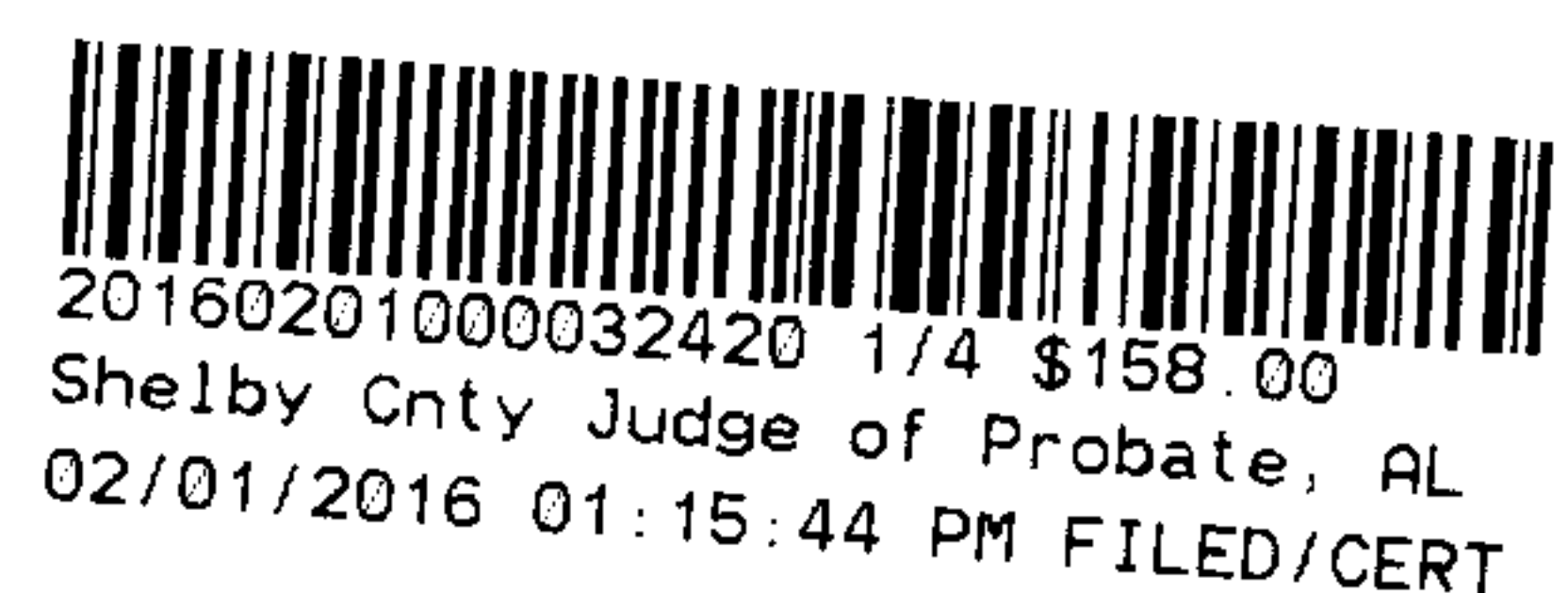

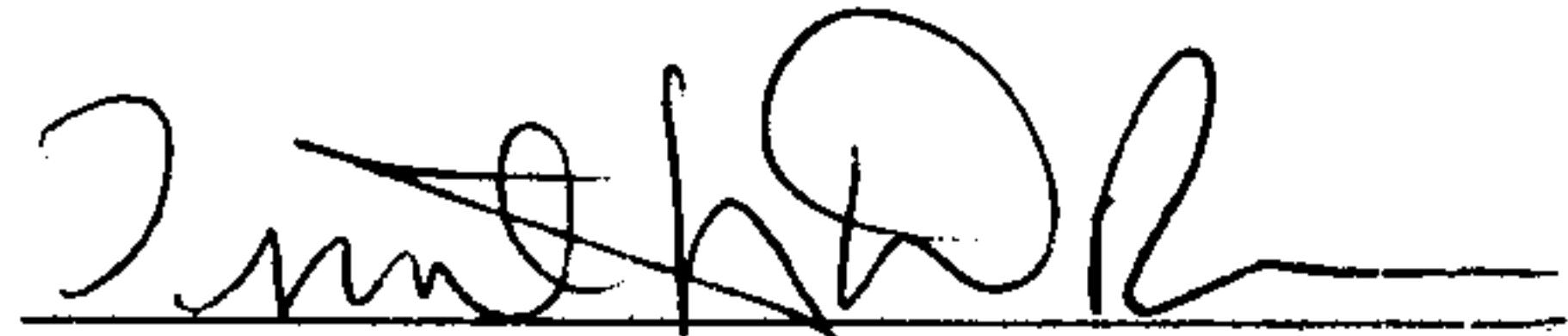

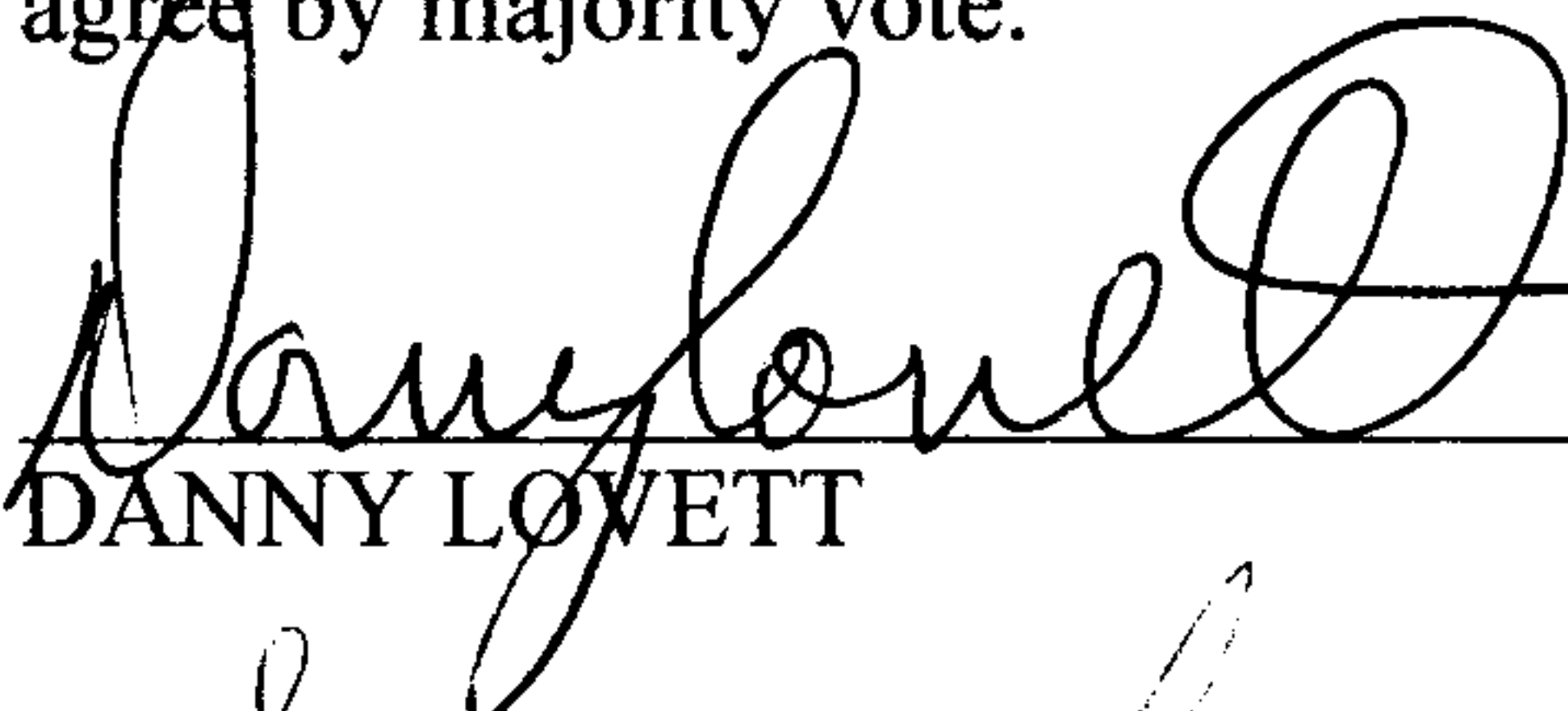
ARTICLE NINE

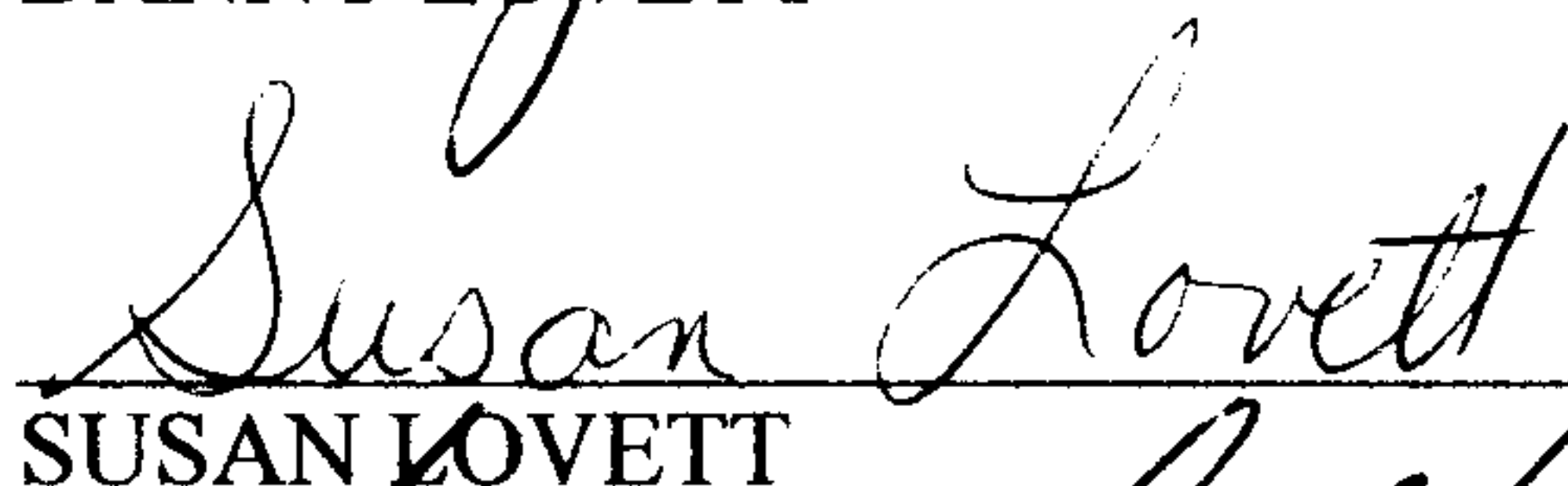
The limited liability company shall have 1 manager(s) who shall serve until the first annual meeting or until their successor(s) are elected and qualified. The initial manager(s) shall be:

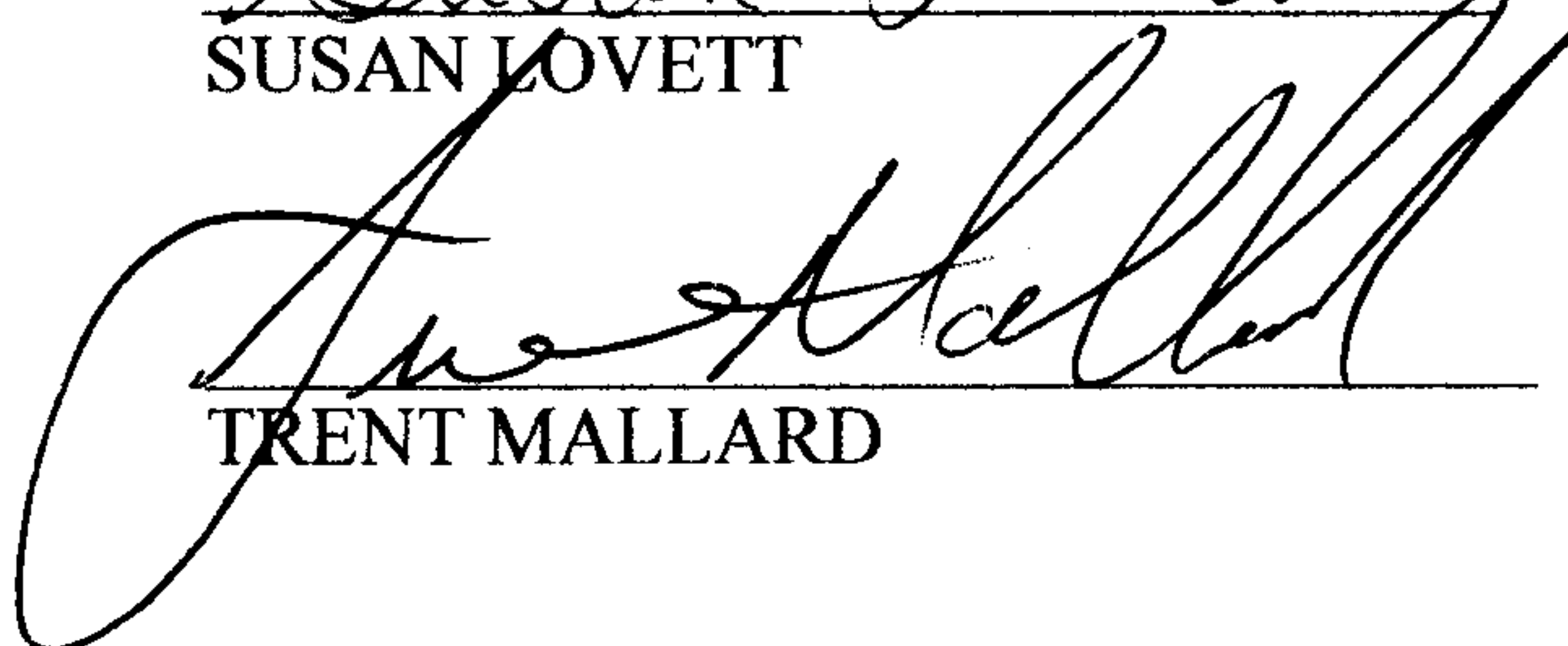
