

Durable Power of Attorney Of Tommy Lou Robbins

- I, Tommy Lou Robbins, do hereby nominate and appoint my son, Michael Craig Robbins, and/or my sister-in-law Glenda H. Robbins, as my true and lawful attorney in fact, to do the following things on my behalf and in my name, place and stead:
- (1) To buy, sell, deed, convey, transfer, lease, mortgage or pledge in any manner all real and personal property owned by me, and to execute all instruments and conveyances necessary therefore;
- (2) To manage, rent, lease or handle in any other manner all real and personal property owned by me;
- (3) To make, endorse, accept and receive all checks, drafts, money orders or cash belonging to me and to deposit the same in a bank or to keep the same in any manner my attorney in fact feels is proper;
- (4) To employ agents, servants, or employees on my behalf and to compensate them for their services;
 - (5) To deal in stocks, bonds and investments of any kind;
- (6) To prepare and execute on my behalf all tax returns of every kind and to pay all taxes of every kind which I may owe;
- (7) To transact any and all other lawful business for me in my name the same as I could do myself;
- (8) To have full and complete access to any safety deposit box which is being rented in my name or to which I have legal access at any banking facility;
- (9) To make all decisions relating to my health and medical care, including giving permission to perform surgery and other medical procedures;
- (10) It is my desire that the power and authority herein given to my said attorney in fact shall remain in full force and effect during my lifetime or until the same is revoked as herein provided even though I may be physically or mentally incapacitated and unable to transact business myself at the time my said attorney in fact acts on my behalf;
- (11) This power of attorney shall not be affected by disability, incompetence or incapacity on my part;
- (12) In the event it should become necessary for a guardian and/or conservator to be appointed for me, I request any court handling this matter to appoint my son, Michael Craig Robbins, as my guardian and/or conservator;
- (13) This power of attorney shall remain in full force and effect and shall be binding on me until such time as written notice of revocation thereof is filed in the Office of the Judge of Probate of Shelby County, Alabama;
 - (14) Nothing contained herein shall be construed as granting a right to my attorney in fact to

make gifts of my property to himself or any other person. My attorney in fact shall act as fiduciary for my exclusive benefit, but shall have latitude of discretion in so doing.
